



Referendum for WPC Phosphorus Project – January 30, 2018

- Connecticut In 2015, the Department of Energy Environmental Protection reissued Plainville's Wastewater Discharge Permit requirement that the amount of phosphorous discharged from the Town's Water Pollution Control Facility ("WPCF") be reduced by 88%. The WPCF must be upgraded to meet these new permit requirements.
- The estimated cost of the project is \$15,761,000, and the Town is eligible to receive an estimated \$6,500,000 grant from the State of Connecticut's Clean Water Fund Program (approximately 41.2% of the project cost). The Town anticipates financing the remaining project cost with a 20-year 2% loan under the Clean Water Fund Program.
- This is a reminder that the referendum to appropriate \$15.76M for upgrades related improvements to the Town's Water Pollution Control Plant and authorize the issuance of bonds and notes to finance the portion of the appropriation not defrayed from grants will be held on Tuesday, January 30, 2018.
- Residents can vote on the appropriation at the Fire House from 6:00 am to 8:00 pm.
- An Explanatory Text describing the referendum was recently mailed to all Plainville residents. People who have questions regarding this project encouraged to contact the Town Manager's Office.

President Trump says he wants Congress to have a deal on immigration and the border ready by the time he returns from the Davos forum in Switzerland—and he says he is open to the deal including a path Trump for citizenship for DACA recipients. "We're going to morph into it," said of citizenship for the Dreamers on Wednesday, per the Washington Post. "It's going to happen—over a period of 10 to 12 years. If somebody's done a great job and worked hard, it keeps the incentive to do a great job," he said. "I think it's a nice thing to have the incentive, after a period of years, of being able to become a citizen." Trump stressed, however, that the deal for roughly 700,000 Dreamers would depend on securing \$25 billion to build a border wall and \$5 billion for

other immigration-related spending. He said reporters could tell Dreamers they had "nothing to worry about." The proposal Trump outlined sounds similar to one that Senate Minority Leader Chuck Schumer said was "off the table" after the shutdown ended, the Hill notes. GOP Sen. Lindsey Graham, who has been pushing for a bipartisan deal-and using the hashtag #TrumpDreamers— Trump's called remarks "breakthrough." "I truly appreciate President Trump making it clear that he supports a path to citizenship for DACA recipients," said Graham, whose own proposals have been called "unacceptable" by the White House. Advocates for restricting immigration say they could support a pathway to citizenship, depending on how many people it applies to and whether it is combined with other measures to limit immigration, the Los Angeles Times reports. By the time you read this, perhaps a deal will be made!

### IT Jim February 2018 Title: In the **News: Spectre and Meltdown Security Vulnerabilities**

As the clock turned to a new year, a new computer security vulnerability was announced that made the news. What are "Meltdown" and "Spectre" all about? They have the potential to be very serious. What do these things mean to you? I will attempt to break this down for you and give you an understandable explanation.

#### What are these vulnerabilities?

Meltdown is a hardware vulnerability. It affects almost all Intel processors (Pentium, i3,i5,i7, Core, Celeron, etc.) going back to 1995. There is a processor in every computer. It also affects ARM processors. There is an ARM processor in every smartphone. It does not affect AMD processors (Athlon, FX, Phenom, Ryzen, etc.)

The vulnerability itself allows a program running on your computer to peek at what other programs are sending through the processor at the same time. Of the two bugs, Meltdown is the easier one to fix. Microsoft, Apple, and other companies have already sent out or are working on updates to fix it.

Spectre is more of a new way that was discovered to attack computers through the processor. This one affects ALL processors from Intel, AMD, and ARM. The feature that is taken advantage of is called speculative execution. It is a method processor manufacturers use to improve performance by predicting what you are going to do next.

This vulnerability is very difficult for the bad guys to take advantage of. It is also very difficult to fix. Microsoft, Apple, Google, Firefox and others are working hard to make patches available that at best can help mitigate the risk. Experts believe the only true fix is to reengineer processors which means having to update or replace the hardware. As such, Spectre is likely going to be an issue for years to come.

#### How do I know if my computer is affected?

and run a small tool from a trusted company Gibson Research. Go to www. grc.com/inspectre.htm . Download and run the program. It will tell you very clearly if you are vulnerable or not. It will also offer guidance on how to handle things if they are.

#### What do I need to do?

Update, update, update!!! Microsoft, Apple, Intel, AMD, and many other companies have released or are working on updates that will protect you against these vulnerabilities. It is extremely important to make sure your computer has all of the updates made available by these companies.

These updates will likely affect the performance of your computer. Generally speaking, the older the computer, the more it will be impacted. Newer CPU's are fast enough to compensate for not having this feature. Older computers can see as much as a 20% loss in performance.

#### Local Lawmakers **Vote to Restore Medicare Assistance for** The easiest way to check is to download

**HARTFORD** Representatives William A. Petit, Jr. (R-22), and State Senator Henri Martin (R-31) on Monday cosponsored and voted in favor of a bipartisan plan that would provide funding for the Medicare Savings Program (MSP) through the end of the fiscal year.

Seniors, Disabled

"Today we acted to restore funding for seniors and those who are disabled. This is a temporary fix, which, while easing the financial burden for those residents, is not a permanent solution. We have far more work to do on finding funding alternatives as we continue to deal with Connecticut's ongoing fiscal crisis," said Rep. Petit.

Realizing almost 86,000 low-income seniors would be disqualified from the program and another 27,000 would have their coverage reduced, members from both the House and Senate of the Connecticut General Assembly petitioned the Secretary of the State to call them back into special session in order to restore the previous cut.

"The legislation passed today shows that health care for Connecticut's low-income seniors and disabled is

a priority for the state," Sen. Martin said. "Today's decision is in line with what the legislature intended when the budget was recently passed. I'm glad this was a bipartisan effort and hope the Governor will reconsider his threat to veto the bill."

The MSP plan was approved in the House through a 130 - 3 vote. Among the methods used to restore program funding is a requirement that Gov. Malloy reduce the number of managers and consultants—a provision included in the adopted budget ignored by the governor. Other components include moving human resource-related functions of some state agencies into the state's Department of Administrative Services, and requiring the governor to find savings in Executive Branch functions while limiting his ability to cut more than 10 percent from any one program.

State senators approved the plan 32 - 1 in a vote later in the day.

The 2018 legislative session—a so-called short session—starts Feb. 7th and will see lawmakers focus primarily on issues tied to the state budget.



#### **ELIZABETH NORTON TRUST FUND GRANTS SUPPORT SEVERAL DISTRICT INITIATIVES**

Several school district programs and initiatives are underway this year thanks to a number of grants received from the local Elizabeth Norton Trust

Linden Street School music teacher Marilyn Speranza received a grant to bring the award winning "a capella" group Backtrack Vocals to all three Plainville elementary schools. The group has toured nationally and has received over 9 million views on YouTube. They will serve as a vocal model for Plainville students while presenting music from the genres of pop, rock and Broadway. Elementary Math / Science Instructional Leader Phil Sanders received a grant to support STEM night programs at all three elementary schools. The STEM night programs feature hands on STEM activities for students and their families, with assistance provided by students in Plainville High School's science classes. The Plainville Family Resource Network also received a generous grant to support the annual Family Fest event for local families held in the spring.

Middle School of Plainville School Counselor Jessica Pepin received a grant which will be used to supplement the cost of transportation and tickets for students from grades 6, 7, and 8 to attend plays that will be offered through The Bushnell Children's Theatre's Educational Series. plays, Warriors Don't Cry & Freedom Train both have themes of social justice and civil rights.

Two grants were received to support programs at Plainville High School. Transportation and Construction Education Instructor David Marchesani received a grant to support the "Bike Shop" project at the high school. The Bike Shop is a collaboration among the high school's Transportation classes, the Plainville Police Department and the Plainville Community Food Pantry. Through the initiative, high school students refurbish old, discarded bicycles collected by the local police, then they are distributed to local youth through the Plainville Community Food Pantry. This year the funding will be used to build workbenches and storage cabinets for the shop as well. Students in the Advanced Transportation class will design the workspace and students in the Advanced Woods class will build workbenches and cabinets.

Plainville High School Library Information Teacher Deb Pikiell

received a grant to redesign the high school's Upper Media Room as a "ColLAB" or Collaboration Lab. The updated room features whiteboard top tables designed to maximize student communication. The room accommodates five groups of five students who can sit face to face, naturally fostering a productive conversation. Groups can brainstorm and revise ideas on the whiteboard top tables as they collaboratively work through the problem solving process. Thanks to the grant, the lab will be completed with a large monitor to connect students' chromebooks, allowing a better visual as they tackle collaborative work.

District Volunteer Coordinator Sue Bradley received a grant on behalf of the +KIK (Positive Kids Influencing Kids) Peer Mentor Program. The program, in its fourth year, pairs Plainville High School students with eighth graders from the Middle School of Plainville to provide friendship, role modeling, and support as the middle school students prepare for the transition to high school. The high school mentors visit their middle school mentees at the Middle School throughout the school year; at the end of the school year, the eighth graders visit the high school and tour the building with their peer mentors in preparation for their start as freshmen in the fall. The grant funding will also provide for a motivational speaker for students in the +KIK Program this year. Finally, Plainville Adult and Continuing Education also received a grant from the Elizabeth Norton Trust to support "Pizza, a Miniseries, and a History Lesson." Participants will watch "Band of Brothers" on the Plainville Public Library's big screen, while enjoying lunch, Saturdays at Noon in March. Viewers will understand key events linked to World War II, and gain an empathetic appreciation for the unselfish contributions of our brave military. In addition to the general public and local history buffs, Adult Education students will be encouraged to participate, so that they may access this realistic supplemental resource, enhancing Social Studies curricula program-wide. Students will also discover the library's vast collection of World War II materials.

# From the Desk Of...... Thomas A. Wurz, Esquire DIVORCE AND THE JUDGE'S DISCRETION

One of the biggest concerns people have when going through a divorce is what a Judge may order if their case goes to trial. The laws in Connecticut are very clear that a judge has wide discretion at trial. This article will take a look at just what the laws outline and why having an attorney to counsel you through the process is an invaluable asset.

When dividing real property, improved or unimproved land, as part of a decree dissolving a marriage, the Superior Court Judge must consider all pertinent evidence regarding the property in order to fix the nature and value of the property to be assigned. Relying on only one piece of evidence would undermine all other credible evidence and render the Court unable to make an equitable decision. Essentially, the laws main goal is to attempt to fix the nature and value of the property to be assigned. A judge may consider all actions that went into the purchase, maintenance, and improvement of the property. This may be monetary or nonmonetary contributions by the parties. So just because one party put up all the money it doesn't mean the other party is not entitled

to their share of the property at trial. How much they are entitled to receive is ultimately up to the judge at trial.

Personal property is divided much the same way by a judge at trial. Divorce court is a court of equity at its core. This means the judge tries to divide the parties' assets in a manner that is just and fair. It does not mean a 50/50 split of all assets is the standard. Since Connecticut is an all equitable state all of the parties' assets are on the table for division at trial. A good note exemplifying how equity does not necessarily mean 50/50 is that a trial judge may find more fault for the divorce by one of the parties, which could grant the lesser at fault party more of their assets. Not a 50/50 split by the judge, but more of an equitable decision based on what the court was presented.

While this does not cover everything, it should highlight the reality that if parties going through a divorce do not negotiate a separation agreement on their own they better be willing to have a judge decide. As always, if you ever find yourself in a legal proceeding, consult with a licensed attorney so that you may better understand and protect your rights.

If there's one thing that all dentists have in common, it's that they regularly see young patients with tooth decay. Roughly 42 percent of children ages 2 to 11 have had decay in their primary teeth, while approximately 32 percent of children ages 9 to 11 have decay in their permanent teeth. ### 12 Strong and America's **Longest War**

12 Strong: The Declassified True Story of the Horse Soldiers hit the multiplexes January 19th. The film, based on Doug Stanton's 2009 non-fiction book Horse Soldiers, tells the story of the first United States soldiers to be sent to Afghanistan immediately after the 9/11 attacks on the World Trade Center and Pentagon While the film starring in 2001. Chris Hemsworth, Michael Shannon, and Michael Pena is in many ways a conventional war film, its release some sixteen years after the incidents it portrays at the beginning of a war the United States is still fighting highlights the unique position the War in Afghanistan holds in American history.

Until the Vietnam Conflict the longest war America had fought had been the American Revolution which began with the Battle of Lexington and Concord in April 1775 and ended with the defeat of General Cornwallis by the Continental Army aided by French forces at Yorktown in 1781 though the formal peace treaty was not agreed to for two more years. Conversely the Treaty of Ghent ending the War of 1812 was signed in December 1814 though the Battle of New Orleans was fought some six weeks later in January 1815 catapulting General Andrew Jackson to renown and eventually the White House. The Civil War lasted four brutal years (1861-1865) as did American involvement in the Second World War (1941-1945). The Korean War (though never concluded with a treaty) lasted three years (1950-1953),

The Mexican-American War lasted from 1845-1848, American involvement in the First World War lasted for just over a year and a half (1917-1918), and the Spanish-American War lasted months (1898) as did military operations during the First Iraq War (1990-1991).

The United States' military participation in the Vietnam Conflict as being "at war" is most often dated by historians from the Gulf of Tonkin Incident and later Resolution in 1964, though American military "advisors" were involved in aiding the French and later independent South Vietnam government going back to the early United States military participation ended with the removal of the "last" ground troops in March 1973. Saigon and South Vietnam would fall in 1975. U.S. involvement in the Vietnam Conflict as at being "at war" is often dated between nine and twelve years (1963/4 to 1973/5) depending on how historians define the involvement. The United States has had active military operations in Afghanistan for over sixteen years now with no immediate end in sight.

In the case of the majority of wars the United States has been involved with few having spanned a time longer than that of a Presidency or a single political party hold on the Presidency. While President Franklin D. Roosevelt did not live to see the conclusion of the war he led his country through with his death in April 1945, it would be his Vice-President Harry S. Truman who would see the surrender of Nazi Germany in May 1945 and Imperial Japan in August 1945 as President. It would not be until the Vietnam Conflict that American involvement would span across the transition of political control of the Presidency between political parties when Richard Nixon, a Republican, took office in January 1969

on the platform of ending the country's involvement in the War begun under the Administration of Democrat Lyndon Johnson (though it can be strongly argued President Johnson was merely continuing President John F. Kennedy's policy regarding Vietnam whom Johnson took office from after his assassination in November 1963).

President Barack Obama, like President Nixon forty years earlier, ran on a platform to end what he viewed as President George W. Bush's flawed policy that had led the United States into a Second Iraq War in 2003. President Obama brought U.S. troops home in 2011 ending the war in Iraq though he had to later send troops back into Iraq due to the rise of ISIS in Iraq after U.S. troops had been pulled out. While President Obama ended, at least temporarily, U.S. involvement in the Second Iraq War, he did not pull the United States out of Afghanistan rather he temporarily increased U.S. troop presence with a surge. Now, under President Trump, American involvement in the Afghan War continues.

12 Strong begins with the 9/11 attacks. For college freshman, many of whom were born in 1999, the 9/11 attacks occurred before they can remember. For today's high school students the 9/11 attacks and America's entry into the Afghan War occurred before they were born. For no other generation of Americans has a war stretched on so long that soon those fighting it will have been born after that war began. If for no reason other than understanding why America entered into its longest war they should see it.

#### **When Your Pipes Burst**


- Make a list of the damaged articles and take photos.
- Save the receipts for what you spend—including additional living expenses if you must leave your home until repairs are completed-and submit them to your insurance company for reimbursement.

For example, if house pipes freeze and burst or if ice forms in gutters and causes water to back up under roof shingles and seep into the house. You would also be covered if the weight of snow or ice damages your house.
- If your home sustains water damage, it is important to make sure that it is properly dried and repaired to prevent any potential problem with mold. Remember, mold cannot survive without moisture.
- Check with your agent or company so you'll be sure what your policy covers.

### Healthy-Behaviors

Frozen, Grateful and Staying Positive

Tips for a Healthy New Year.

At this writing, it is relatively balmy compared to the start of 2018. I didn't think the furnace would ever stop running. Walking my dog Cooper was particularly challenging as it took longer to put on multiple layers and add the hand warmers then it did to take the walk. I suspect this warm spell won't last for long.

Even though it has been bitterly cold outside, my morning routine of a green smoothie continues. Very grateful to be able to open the freezer and use the strawberries and blueberries purchased at their peak at the farmers market this summer. Normally, I add kale, chia seeds, fruit and a cucumber to my smoothie. Once cold weather hits, I drop the cucumber because they just don't look as good or have the same fresh taste. I'll be happy when they are back in season.

Best practice is to eat local food when it is in season. Fresh fruits at the grocery store now are more expensive, don't have that just picked look and some of the flavor and nutrients are lost in transportation.

One thing that is consistently agreed upon in the health community is that 3-5 servings of vegetables and 2-4 servings of fruit per day are an important part of a healthy diet. It's a bit more challenging in the winter, but here are some tips:

☐ Frozen fruits and vegetables are good alternatives. Happy as well for the corn we froze this summer.

Enjoy warming soups using winter vegetables such as cabbage, broccoli, carrots or turnips.



1 cup hot chicken bouillon 3 tablespoons butter

3 tablespoons flour



PLAINVILLE - Budgets, the Farmington Canal Heritage Trail and the proposed water pollution control facility were the big topics at the annual "State of the Town" forum Thursday.

Held at the Plainville Public Library, the forum was hosted by the Plainville Chamber of Commerce. It included Kathy Pugliese, Town Council chairwoman, Maureen Brummett, superintendent of schools, Robert E. Lee, town manager, John Bossi, director of technical services and Mark Devoe, director of planning and economic development.

Following each of their presentations, there was a brief question and answer segment which saw participation from state Rep. William Petit, Tim Stewart, father of New Britain Mayor Erin Stewart and resident John Kisluk.

Kathy Pugliese gave a recap of challenges which the Town Council had taken on recently. These included applying for state grants for improved railroad crossing markers, the remediation of the Plainville High School track, redevelopment of the White Oak and Chung properties and the dog park proposal.

It also included the boiler replacement and LED lighting upgrades at the Middle School of Plainville, the water quality study, the Wheeler school renovations, the Farmington Canal Heritage Trail study, the mandated upgrades to the town's water pollution control facility and the challenges of state aid cuts.

Brummett said that Plainville schools are "very

fiscally responsible." She said that the school budget had increased by an average of 1.06 percent over the past 7 years. However, the state cuts to education funding were going to prove challenging.

"The impact has been that we did not hire a teacher to replace one that retired in Wheeler school, increasing class size," she said. "We have also put off some preventative maintenance and we are cutting the number of supplies such as books that each classroom receives. We have not yet reduced our staff, but if more cuts are coming down the line then a reduction of programs and staff are anticipated."

Lee's portion of the presentation focused mostly on the town budget and the Farmington Canal Heritage Trail project.

He explained that the town had consistently passed balanced budgets. Lee explained that the challenge had come when the state didn't inform the town until half-way through the fiscal year that they'd be getting \$1.9 million less in state aid than was originally projected.

This ultimately resulted in town staff searching for additional cuts and passing the first supplemental tax bill in town history to try to make up for the shortfall.

"Our mill rate has increased by an average of 1.64 percent over the last five years and that includes the supplemental tax bill," Lee said.

As for the trail, Lee said that it could allow for safety improvements to be made to Pierce and Broad Street and that it would also give residents a chance to appreciate some of the town's natural features.

Bossi elaborated on the water pollution control facility upgrades, explaining that they were intended to kill algae in the water by removing phosphorous. He also explained that before water is discharged it is hit with ultraviolet rays that kill bacteria and viruses. If the project is approved at referendum Jan. 30, construction will begin this year.

Devoe said that as director of planning and economic development, his goal was to "create conduits for economic support." He noted that 35 businesses have opened in town in 2017, many of which filled long-vacant properties. He also made mention of businesses that were expanding in town.

Petit gave his kudos to the town leaders. "In Plainville, I see people working together for the greater good of the community," he said. "In other communities there is significant partisanship and as a result, things run much less efficiently. Plainville should be really happy with the leaders that it has."

Stewart said that Plainville was "remarkable" in the way that town leaders were able to work together to come up with long-term plans for the community.
