


It will be a sad day on February 5th as John will be retiring after almost 43 years with the Plainville School System. He worked days as the custodian for Wheeler School.

December 7, 2020 Treated and Non-Treated Road Salt

- **Bids**
- The Roadways Department is seeking Town Council approval to purchase both treated and nontreated winter salt materials. Typically, nontreated salt is utilized in warmer conditions above 17 degrees while treated salt is used in temperatures below 17 degrees.
- The first item is untreated salt. Town staff is recommending the purchase of nontreated from Champion Salt of Maryland Heights MO at a cost of \$58.00 per ton. Champion Salt was the low bidder through a State Bid process. This price per ton is \$1.75 per ton less than what was paid last year. (\$59.75)
- The second item is treated salt. Town staff is recommending the purchase of treated salt from DRVN Enterprises of Wethersfield, CT at a cost of \$63.50 per ton. This is a negotiated price which is also \$8.00 per ton less than last year.
- There are two items under New Business regarding the purchase of nontreated and treated salt as recommended by Town staff.

Eversource Gas Replacement and Expansion Project

- Earlier this summer Eversource Gas notified Town staff that they were planning to make some substantial upgrades to their distribution system in Plainville over the next ten years. This was immediately concerning because their plans included replacing gas lines in recently paved streets.
- For the last five years, Town staff had annually contacted the companies, utility including Eversource, requesting their future construction plans in order to avoid a situation where a town road was to be dug up shortly after being re-paved. At no time did Eversource Gas inform Town staff of their plans until this summer. When these plans were received, Town staff immediately contacted them to express our displeasure and notifying them that they would have to make some adjustments to their replacement schedule.
- Town staff has had several with Eversource meetings

- In addition, Eversource has stated that they plan to move forward with extending gas service on Redstone Hill Road and the neighborhood that includes Hollyberry Lane, Skyline Drive and Highland Drive. This was originally discussed with Town staff about 18 months ago but their plans were delayed.
- This expansion work is expected to begin early next year.

Robertson Airport Update

- There are several projects underway at the airport. The reconstruction of the taxiway is being done by Tilcon and is about 90% completed. This is a \$2.72M project that is being paid through a grant provided by the F.A.A.
- Additionally, the Town has made some improvements to the airport facilities utilizing monies in the Airport Fund. Improvements that have already been made include the painting of three hangars (including the administration building) and the replacement of several heating/ cooling units. The Town is also looking to replace the metal roof on Hangar 4 as it currently has some leaks and has reached its useful life. Interstate Aviation and the Town have also agreed to make improvements to the administration building. The interior floorplan is being modified by Interstate and the Airport Fund will contribute to some of the exterior work including new windows and doors and a new handicapped accessible ramp to the main entranceway. The plans also include improvements to an adjacent patio area which will allow residents to have a place to observe the airfield.
- Interstate is also planning to construct a small café inside the administration building. The improvements to administrative building are expected to begin during the winter months with the replacement of the Hangar 4 roof to occur next Spring.

Town Clerk Position

Town Clerk Carol Skultety recently announced her plans to retire in January. Carol has worked for Plainville since 1998 first serving as the Deputy Revenue Collector and then becoming the Deputy Town Clerk before being appointed as Town Clerk after Peter Lennon retired in 2003.

she has held since 2014. Before that she served in the Bristol Town Clerk's Office in several supporting capacities for 14 years.

- A final interview with myself and Stacy Buden was held on December 3rd. Pursuant to the Town Charter, I am pleased to announce that I have appointed Cindy Porrini to serve as the Plainville Town Clerk beginning on January 4th. This will allow for some overlap time with Carol Skultety to acquaint her with the office.
- I want to thank Carol for her 20+ years of dedicated service to the Town of Plainville and wish her well in her retirement.

CIP Additional Appropriation

- The FY 21 Capital Improvement Budget anticipated that \$980,000 would be contributed from the Towns' unassigned fund balance to support the approved projects. According to the Town Charter, the Town Council is required to conduct a public hearing before considering an additional appropriation.
- The Town Charter also requires a referendum whenever any additional appropriation exceeds 1% of the Town Budget. As a result, in order to appropriate \$980,000 from the unassigned fund balance, two supplemental appropriations will be required in order to avoid the expense of conducting a referendum.
- There is an item under New Business establishing a public hearing for Monday, December 21, 2020 at 7:00 pm to receive public comments regarding the appropriation of \$490K from the unassigned fund balance to the Capital Improvement Fund. A second appropriation will be planned later in the fiscal year.

FY2022 Budget Discussion

- Town staff is currently making plans for the development of the FY22 Town budget. One of the first steps in the budget process is a joint meeting with the Town Council and the Board of Education.
- During this joint meeting, both Town and School Administrative staff update both boards on the status of the current budget year and the projected budget assumptions and expectations for next year.
- This meeting is generally held in mid-January. Given the current

Middle School Discussion

• Superintendent of Schools Steve LePage is participating in this evening's meeting to discuss the potential renovation of the Middle School. He will discuss the need for the project, a potential timeline, and the next steps for moving forward with the project.

Valley Water Rate Increase

- Several weeks ago, Valley Water notified the Town that they had filed an application to the Public Utilities Regulatory Authority (PURA) for an increase in the water rates. Valley Water pointed out that the last time there was a rate increase was in 2010.
- They are requesting an average rate increase of 35.73% which would raise their revenue by \$1.23M. They also pointed out that the rate increase does not include any construction costs or operating costs associated with the new Woodford Ave. water softening plant which is scheduled to be built next year.
- An analysis of their application shows that a residential customer with a monthly water bill of \$25 would see an increase of 38.75% or \$116.26 per year. A customer averaging \$35 per month would see an increase of 36.18% or \$151.96 per year. Finally, a residential customer with a monthly bill of \$50 would see an increase of 34.25% or \$205.51 per year.
- In addition to the increase in the residential rates, there will also be significant increases to the commercial and industrial rates as well. These increases, while significant, will be less than the residential rate increases.
- Valley Water is also proposing a 24,52% increase for Public Fire Protection services rate. If approved as requested, the Town Budget would see an increase of \$168,196. The Town currently pays \$685,872 for fire protection services.
- The next step is for PURA to review the application and, at some point, conduct a public hearing. Information regarding the proposed rate increase can be found on the Town website at www.plainvillect.com as well as the PURA website at www. portal.ct.gov/PURA. The docket number for the application is 20-11-14.

Self-Insurance Health Fund

• Two years ago the Town joined t

CT State Partnership Plan to provide health insurance benefits to Town and Board of Education employees. Before that, the Town self-insured for these health benefits. The selfinsurance program was in place for approximately 20 years. For the great majority of those years, the Town saved significant monies compared to the average of the fully insured rate increases during the same time period.

- However, in the last several years of the self-insurance program, the claims significantly exceeded the allocated contributions. The selfinsurance fund currently has a deficit of \$2.37M.
- To eliminate this deficit, Town staff is recommending that the Town Council adopt of plan to utilize savings in the debt service plan. During the next 4 years, the debt service line item will have savings of over \$3M. This amount would eliminate the deficit in the selfinsurance fund.
- If this path is taken, instead of having the savings accrue to the Debt Management Fund – the savings would accrue to the General Fund instead. When that occurred, the Town Council would then annually authorize an appropriation to the self-insurance health fund.
- If the Town Council is supportive of this approach, Town staff will prepare a policy statement to be considered at a future meeting.

Municipal Coronavirus Relief Fund (CRF) Program

- The State has established a Municipal Coronavirus Relief Fund to reimburse Towns for costs incurred as a result of the pandemic. These funds can be used to pay for the improvements made to municipal facilities to protect workers and visitors.
- Improvements to date have been made to the Municipal Center, Library and the Senior Center. Plainville's allocation from the Coronavirus Relief Fund is \$261,533.06. A separate relief fund has been established for education building improvements and operating costs as well.
- There is an item under New Business that would authorize the Town Manager to execute all necessary documents to receive funding under this grant program.

Personal Property Audit Update

• The FY20 Town budget included \$15K to perform personal property

- audits to randomly chosen manufacturing companies in Plainville. The Assessor recently completed 13 audits which increased taxable assessments by \$10,341,270. The audited businesses were notified of the proposed changes and were given the opportunity to meet with the auditing firm to answer questions and to provide additional information to make sure the proposed adjustments were in line with State Statutes.
- These additional personal property assessments will result in \$505,753.53 in tax revenues for the current fiscal year. The tax bills related to the personal property audits will be mailed before January 1st and businesses can choose to have 90 days to pay them without delinquent interest charges being assessed.

Christmas Tree Disposal

- Residents may bring their Christmas trees to the Transfer Station on Grainger Lane for free disposal beginning on Monday, December 28th. If the tree is transported in a bag, the bag must be removed before it is deposited in the appropriate location at the Transfer Station.
- The Roadways Department will be conducting curbside collection of Christmas trees during the week beginning January 11th.

COVID-19 Update

- Positivity rates continue to increase in Plainville and the surrounding Towns. The daily State positivity rate now stands at 6.85%. During the last two weeks, Plainville has had an average daily rate of new cases of 64.4 per 100,000 population. There are only two Towns in CT that are currently not under the "Red Alert" status.
- Governor Lamont recently issued Executive Order 9R. This order allows for municipal tax payments due on January 1st to have a 90day grace period before delinquent interest is imposed. This is the same program that was taken with the July tax bills. Residents who wish to have an additional 60 days to pay their January 1st tax bill will be required to fill out a Municipal Tax Deferral Form by February 1st. This form is available on the Town website at www.plainvillect.com

Residents who participated in the

earlier program will be notified via email of this new program. There will also be notices posted on social media and press releases will be issued as well.

 State Health Department also announced that they are recommending that the quarantine period for those who have come in close contact with infected individuals and showing no symptoms be reduced from 14 days to 10 days.



Robert Lee Town Council Report January 4, 2021

White Oak Proposals Update

- In April 2017 (almost 3 years ago), the Town of Plainville entered into an "Access & Option Agreement" with the Estate of Roger L. Toffolon for what is known as the White Oak property located at 1 West Main Street and 63 West Main Street. The Agreement gave the Town the exclusive option to purchase the property for the sum of \$1.00.
- The Agreement was for the period through September 15, 2018 although that date has been extended several times and now runs to June 30, 2021.
- The desired purpose for entering into this Agreement was "for the purposes of downtown revitalization". The Agreement required the Town to perform an environmental assessment and to obtain an environmental assessment grant from the State Department of Economic & Community Development.
- Town hired Loureiro, The licensed environmental а consulting firm, to perform the evaluation. On October 7, 2019, Loureiro gave an update to the Town Council which included three potential concepts for the development of the property. The Town Council discussed the concept plans for the development of the property and the consensus was one which "made use of more apartment space, commercial space, more parking areas and recreational areas as well".
- Loureiro completed their evaluation in March 2020. They issued three reports - Conceptual Remediation Plan, Phase II/ Subsurface Investigation III Report, and Planning & Potential Reuse Study Report Title. The Town then applied for a groundwater reclassification for the property and acceptance into the Abandoned Brownfields Clean-up Program. Both of these applications have been successfully completed.
- This past Fall the Town issued a Request for Proposals for developers and received two responses – D'Amato/Meyer and Manafort et. al. The Town then engaged Loureiro to perform a

Shane Lockwood, over the past few weeks, the pandemic continues to spread as expected. The region continues to see new cases every day with a positivity rate between 5-9%. This section contains front line health care workers, first responders (with direct patient care) and resident of long-term care and related facilities.
- The U.S. will hit the three-week mark today for vaccine distribution that is expected to last well into the summer. According to the CDC, as of today - 4.5 million persons have received the COVID-19 vaccination. As more information becomes available in the coming weeks and months on vaccine distribution and eligibility, the health district will update the town website and the health district website (PSHD)
- In Plainville, there are 13 education employees and 5 town employees that are currently under quarantine under CDC guidelines.

Excitement, because you have taken the steps to achieve specific objectives either lower cholesterol, lose weight or reduce blood pressure. Dread because it's going to turn your daily meal planning upside down. You will be counting, measuring, buying new foods that you don't know what to do with and you will be hungry all the time. Good Oral Health is Essential During Pregnancy.....

It's no secret that pregnancy is an important time in a woman's life. While women often hear about how pregnancy causes physical changes that affect their hormone or appetite levels, these changes can have a great effect on their oral health as well. Despite the fact that good oral health is esssential for the overall health of both mother and child, only 22 to 34 percent of women in the United States visit a dentist during pregnancy. In fact, dental care during pregnancy is not only safe and effective, it's essential for combating the adverse effects of oral disease, according to an article published in General Dentistry, the peer-reviewed clinical journal of the Academy of Gereral Dentistry (AGD). Dentists have the ability to maintain the oral health of expectant mothers by treating the dental findings that are common during pregnancy.

Gingivitis, a buildup of plaque that causes inflammation of the gums, should be treated with a professional cleaning and proper toothbrushing and flossing. If left untreated, gingivitis can lead to periodontitis, a more serious form of gum disease. Patient tend to delay the treatment of oral disease due to concerns for fetal safety; howerver, routine dental treatment can be performed safely at any time during pregnancy with preference being toward the first and third trimesters.





What's more, untreated dental disease can lead to pain, infections and unnecessary exposure to medications, any of which could harm the developing fetus. Poor oral health also can affect the nutritional intake of expectant mothers, which is essential for fetal growth and survival.

The hormonal fluctuations that result from pregnancy can produce benign pregnancy tumors in the mouth. These tumors usually appear after the first trimester and typically go away after delivery; however surgical removal may be required when these tumors bleed, interfere with eating or do not resolve after delivery.

In addition to examining for oral disease, dentists may notice dental erosion--the chemical or mechanochemical destruction of tooth material--in pregnant women, due to increased acid in the mouth following morning sickness.

To neutralize acid after vomiting, pregnant women should rinse the mouth with a mixture of a teaspoon of baking soda dissolved in a cup of water. Teeth should be brushed only after the mouth has been rinsed and acid has been neutralized to prevent further damage to the enamel. Oral health assessment and treatment should be an essential part of prenatal care, as these steps allow the patient to receive ongoing advice concerning proper oral hygiene and infant health care.

Social Security benefits continues to be a hot topic for most people as the economy struggles to get back on track and the baby boomer generation inches closer to retirement. In this article, I will outline some of the most prevalent questions I receive concerning benefits and what people need to know.

BENEFITS

The most common question I get about Social Security is, "How much income can I earn and not have my benefits affected by the administration?" In 2013, if you have reached your full retirement age of 66 already you may keep all of your retirement benefits, no matter how much income you earn. If you are going to turn 66 in 2013, then SSA will deduct \$1 from your benefits for each \$3 you earn above \$40,080 until the month you reach full retirement age. If you are younger than 66 during all of 2013, the SSA will deduct \$1 from your benefits for each \$2 you earned above \$15,120.

The next most common question I get is "Can I receive SS benefits through my spouse or ex-spouse?" If your current spouse receives SS retirement or is eligible for retirement or disability benefits, you may be entitled to SS benefits even if you never paid into Social Security. You would need to be at least 50 years old for spousal disability benefits or at least 62 years old for spousal retirement benefits.

The same standard applies for receiving benefits through an ex-spouse with the additional requirement that you were married to them for a minimum of 10 years. All SS benefits are subject to a calculation

The Return of the 1950's Blacklist By: Francis Rexford Cooley

In the wake of the violent protest at the United States Capitol on the day the Congress ratified the election of Joe Biden as President numerous conservative voices have been silenced by on social media including President Trump. There have been calls for "re-educating" Trump supporters, the putting of Republican U.S. Senators, like Ted Cruz, on the "no-fly" list, and for people to be fired (Chapman University professor John Eastman, who spoke at Trump's January 6th rally was quickly forced into retirement after other faculty members at Chapman demanded him to be dismissed). Parler, a rising competitor to Twitter, found itself without access to the internet when Amazon Web Services ceased to provide services without warning.

The chilling assault on speech the political left disagrees with has been led by tech companies; Amazon, Twitter, and Facebook. The actions to limit conservative voices is reminiscent of the actions in the Cold War to limit the political voice of the Left. The hearings of the House Committee on Un-American Activities led to the banishment from the American film industry of the Hollywood Ten, who refused to testify and name names in the fevered search for Communists. Senator Joseph McCarthy (R-Wisconsin) famously waved what he claimed we names of Communists working in the Federal Government. McCarthy held hearings in the U.S. Senate. Just being called to testify before either the House or Senate hearings almost always meant one would lose their job.

Industries followed the lead of McCarthy and others calling for the purging of suspected Communists and others from their companies. Hollywood studios employed what became known as the "Blacklist" to identify individuals who would not be hired. Publishers dropped authors. Workers lost their jobs. Senator McCarthy's campaign, mostly based on inuendo and hyperbole rather than fact, destroyed the lives of many people who were not Communists. McCarthyism entered the lexicon as a noun, "a campaign or practice that endorses the use of unfair allegations and investigations." While Senator McCarthy's political star crashed when he took on the United States Army and the Supreme Court under Chief Justice Earl Warren made a series of rulings that brought an end to the demagogic attacks the Hollywood Blacklist survived until 1960.

The success of Spartacus, at the box office and critically, brought an end to the Hollywood blacklist in 1960. Kirk Douglas acquired the rights to Howard Fast's novel about the Roman revolt from 73-71 BC. Fast had been blacklisted by major publishers after being imprisoned for contempt of Congress for refusing to name names before the House Committee on Un-American Activities in 1950. Douglas hired blacklisted screenwriter and member of the "Hollywood Ten," Dalton Trumbo to create a script based on the novel. Douglas had enough clout in Hollywood to get Universal Studios to release the picture which garnered four Academy Awards in Best Supporting Actor, Best Cinematography, Best Production Design, and Best Costume Design. The film also dominated the American box office as the top grossing film of 1960.

It took a decade for the Hollywood Blacklist to be brought to an end, an end that coincided with the collapse of the studio system which had controlled film production since the early Twentieth Century. Kirk Douglas formed his own production company in 1955 producing Paths of Glory in 1957 and Spartacus, both directed by Stanley Kubrick. Douglas was able to break the blacklist because he could finance his films outside the studio system. A new blacklist enforced by the tech giants, whose first victim was Parler, a competitor to Twitter, is less likely to be broken as quickly as the Hollywood Blacklist.

A sobering thought for the fate of free speech and free thought in this digital era.



Top 5 Things Small Businesses Should Know

CONNECTICUT – The U.S. Small Business Administration (SBA), in consultation with the U.S. Treasury Department, re-opened the Paycheck Protection Program (PPP) on January 11, 2021 for new borrowers and certain existing PPP borrowers. This round of the PPP continues to prioritize millions of Americans employed by small businesses authorizing up to \$284 billion in forgivable loans for job retention and coverage of eligible expenses.

1. Small Businesses can begin to submit applications.

The SBA is currently accepting Paycheck Protection Program (PPP) loan applications from participating community financial institutions (CFIs) and lenders with under \$1 billion in assets. The program will open to all lenders on Tuesday, January 19, 2021. Borrowers can apply for a First Draw PPP Loan until March 31, 2021. Lender Match can help businesses find a participating lender.

2. If a Small Business didn't access a PPP loan prior to 12/27/2020, they may be eligible for a First Draw PPP loan.

First Draw PPP Loans can be used to help fund payroll costs, including benefits, and may also be used to pay for mortgage interest, rent, utilities, worker protection costs related to COVID-19, uninsured property damage costs caused by looting or vandalism during 2020, and certain supplier costs and expenses for operations. See First Draw PPP Loan Overview for more details. Translations available in Spanish and 16 other languages.

3. SBA will ensure increased access to capital.

Building on the success of the first round of PPP, SBA is continuing to address potential barriers to access to capital for minority, underserved, veteran and women-owned business concerns. The Economic Aid to Hard-Hit Small Businesses, Non-Profits, and Venues Act (Economic Aid Act), includes set asides for new and smaller borrowers, for borrowers in low and moderate-income communities and for community and smaller lenders (Guidance).

4. Second Draw PPP Loans are available

SecSecond Draw PPP Loans are available for eligible borrowers who previously received a PPP loan, have 300 employees or less, and have suffered a 25% reduction in gross receipts. 5. FREE Business Resources

Extensive business assistance is available through Connecticut SBA's traditional and non-traditional resource partners. Headache? What's the Confusion?

A lot of people do not know that physical therapy can treat headaches. Physical At Тһегару Sports & Medicine Centers of Plainville, our goal is to educate and



help as many people in the community as we can. If you're a human being, chances are you've had a headache before. Whether it's the result of something minor - think screaming children or a bad night's sleep - or a serious medical condition, headaches can be a real pain in everyday life.

Most people don't know that there are various types of headaches, each with different symptoms and approaches to treatment. Being able to identify which type of headache you're experiencing will allow you to more quickly deal with it, and recognize when a trip to the doctor is in order. The Two Types of Headaches

There are two general categories for headaches: primary and secondary. The causes and symptoms of these types of headaches are broken down below.

Primary Headaches

main distinction The between primary and secondary headaches is what causes them. Primary headaches represent the pain in and of itself, while secondary headaches

else in the mind or body. Primary Headaches Include: Tension type headaches include 1. a dull, constant pain felt on both sides of the head. Other symptoms can

include tenderness, a feeling of pressure behind the eyes, and sensitivity to light and sound. Tension type headaches are the most common type of primary headache, affecting 90% of adults, but they can usually be treated with overthe-counter pain medication. Still, if you've experienced a headache on more than 15 days within a month, you should see a clinician.

2. Migraines are characterized by an intense throbbing pain on one side of the head. They will affect 28 million people in the U.S. at some point in their lives (roughly 12% of the population) and usually include periods of depression, irritability, loss of appetite, nausea, tingling in the hands and/or face, fatigue, difficulty concentrating and neck stiffness. Migraines can also often include "auras" - visual and sensory disturbances that usually last between 5 and 60 minutes, such as dark spots in your vision, dizziness and/or flashing lights.

3. Cluster headaches are rare and usually the most painful type of the primary headaches. Only 1 to 4 % of the population will experience a cluster headache, with men more affected than women and peak prevalence between 27-30 years old. There has also been shown to be a connection between individuals who suffer from these attacks and those who've experienced personal trauma. Cluster headaches are most common during or following periods of sleep, with symptoms including sudden onset severe pain in the head along with possible forehead sweating.

1.Secondary Headaches:

A secondary headache is caused by another issue somewhere else in the mind or body.

Secondary Headaches Include:

Post Traumatic Headaches are 1. headaches that occur within a week of head injury or losing and regaining consciousness. Acute versions of these headaches are ones that come on suddenly and intensely, while chronic headaches occur consistently over an extended amount of time. Both are similar in feeling to tension-type headaches and can also include light sensitivity.

2. Dehydration Headaches are caused by not having enough fluid in the body, and can range in severity from mild to severe as a migraine. Dehydration can happen to anyone at any time, but certain people are at higher risk, including infants, the elderly, people with chronic illnesses, endurance athletes, and people who live in hot climates or higher altitudes. Symptoms can include dull pain or intense migraine occurring at the front, back, side, or all over the head, as well as at the back of the neck. 3. Cervicogenic headaches are characterized by pain referred from bony or soft tissue structures in the neck, but can be present with or without trauma to that area. Symptoms of these headaches, typically triggered by head or neck movements, can include broad or targeted pain in the lower back of the head, radiating up to the top and sides of the head, stiff neck, and pain when coughing.

4. Headaches caused by cold or sinus infection share similar symptoms as cervicogenic headaches but are caused by different issues. A head cold is a viral infection that leads to common cold symptoms, such as runny nose, coughing, body aches and headaches. A sinus infection is usually caused

by a bacterial infection, but can sometimes also caused be a virus. If you experience any cold symptoms, you should see your primary care physician who will be able to prescribe medication.

Ok, I think I know which headache I've been experiencing – but how do I get rid of it?

Most headaches are short-lived and no cause for concern. The obvious first step to treatment is drinking water, taking a rest, and perhaps taking overthe-counter medicine like ibuprofen or aspirin. On the other hand, if you're experiencing severe pain, or a headache that has lasted for days or weeks, you should see a doctor, who will assess, offer further diagnosis and potentially specific medications.

things cervicogenic For like headaches, post-traumatic headaches, or even regularly occurring tension headaches, physical therapy may be the most effective treatment. A physical therapy program may include manual therapy, exercises and stretches to relieve pressure from the surrounding areas, assessment of jaw tension, education on proper posture and biomechanics, and trigger point dry needling – all with the benefit of treating the root cause of the problem, instead of just masking the pain with medication.

There are many ways to manage the varying types of headaches but understanding their symptoms and causes can lead to a quicker solution, and less pain in your life.



This is the story of a young mother, Sandra (Clare Dunne) and her two young daughters, Molly (Molly McCann) and Emma (Ruby Rose O'Hara) who escape an abusive household only to be stymied by a broken housing system. Living in a barely adequate hotel room, working two jobs and resisting overtures from her abusive husband

to reconcile, she sets out to build a home for her children with little resources, sparse help and limited insight on how to accomplish it. As she slowly works on her goal while struggling to build a better life for herself and her adolescent daughters, she discovers the kindness of others while rediscovering her true self.

"Herself" is an emotionally powerful look at the difficulties imposed upon women seeking refuge from an abusive relationship and how the system stacks the deck against them. It pulls no punches (no pun intended) in portraying the physical punishment The Circumspect Critic by: Robert James O'Dell Herself (2020)

Sandra endures nor the emotional distress inflicted as she tries to navigate the Dublin social service system intended to help her get on her feet. After escaping the physical punishment that had been inflicted on her by her husband, Sandra must support her family on the meager wages she earns as a housekeeper for a woman doctor recuperating from a debilitating back injury as well as waitressing at a local pub. Her case manager gets her put on a list for affordable housing but the list is long and the waiting period could stretch into years. Sandra is sent out by her social worker to different rental prospects only to be relegated to standing in long lines while the property gets swept up by someone further up the line.

Director Phyllida Lloyd demonstrates an emotional reserve toward the subject matter proving she can handle the sensitive nature of the material. She proves to be an actor's director allowing the fine cast to shine without burdening them with flashy directorial flourishes that are unnecessary to tell such an intimate human drama. Such restraint is admirable and a bit of a surprise from the director of Mama Mia and The Iron Lady.

The real surprise here, though, is Clare Dunne. The little known actor with a sparse resume highlighted by a minor role in "Spiderman: Far From Home" is nothing short of revelatory. Besides giving an award calibre performance in the lead role, she is also responsible for the original story as well as co-scripting the screenplay with Malcolm Campbell. Dunne gives a fiery performance as a woman beaten down but not defeated. She isn't afraid to show the flaws of this



complex character creating a well rounded portrait of a woman who is flesh and blood real.

Strong acting abounds in the film. Harriet Walter brings world weary strength to Peggy, the doctor who employs Sandra as a housekeeper. Their growing bond anchors the film as Peggy develops into a sort of motherly mentoring figure to Sandra as well as the catalyst to her accomplishing her goal.

Conleth Hill as Aido, the reluctant contractor who takes on the responsibility of overseeing the construction of Sandra's house, gives a likable take on the gruff heart of gold sort.

The two child actors playing Sandra's daughters are pitch perfect in their natural, unassuming interactions with Dunne, giving a gleam of sincerity to the parent/ child bond.


The film has a lot to say about the endurance of the human spirit. From being broken to experiencing a rebound, it is there to lift us no matter how far down we have fallen. It also reaffirms the positive nature of people and how we are there for those who are down on their luck. It's a feel good sort of film despite its overall theme of abuse. It's uplifting as it shows us the power of a mother's love as well as the empathy of the community. The film ranges from heartbreaking to life affirming without ever becoming manipulative. It's a mature tearjerker which manages to be life affirming, leaving you feeling empowered, enlightened and entertained.





INCREMENTAL ISLAM 10 (Part 1)

In last month's article, we discussed the problem of disingenuousness when Islam is included in "Interfaith Dialogues." And how about the non-Muslim who has lived in Muslim communities and knows all too well the painful truths of Islam, or the young Muslim girl who is dreading a trip to the family homeland where she is to be married to a much older man who may legally beat his wives?

How will these more knowledgeable students feel about reading and regurgitating lies?
