







# Robert E. Lee, Town Manager's Report to Town Council JUNE 2020 Meetings

### June 1, 2020

### 4th Quarter Transfers and Additional Appropriations

- Finance Director Rob Buden is finalizing the necessary transfers and additional appropriations to close out FY20 which ends on June 30th. He expects to complete this work early next week.
- Under New Business is a motion to establish a Public Hearing on June 15th for the 4th Quarter Transfers and Additional Appropriations for FY21.

### Revenue Collector's Suspense List

- In accordance with Connecticut State Statutes, the Revenue Collector has prepared the Suspense List of those taxes that are considered "uncollectable". These "uncollectable" taxes fall into four main categories namely: motor vehicles, personal property, real estate and deceased persons.
- The amount recommended for the suspense list totals \$181,847.97. Once the suspense list is approved efforts will still be taken to collect these taxes. Efforts will include engaging a collection agency, town attorney and Town constables. In fact, over \$33K was collected in delinquent taxes and interest from last year's suspense list.
- There is an item under New Business regarding the recommended Suspense List.

### **COVID-19 Update**

• There will be updates regarding summer camp, pool operations, playgrounds and group gatherings.

### **Summer Schedule**

• The Town Council has historically reduced the number of regular meetings during the summer months. Town staff is suggesting that the Town Council consider cancelling the meetings held on the first Mondays during the months of July (6th), August (3rd) and September (8th)

### June 15, 2020 WPC Air Conditioning Units

- The three air conditioners at the treatment plant need to be replaced. They are over 20 years old, have had numerous repairs and are currently out of order. Bids were solicited by Superintendent Joe Alosso and three proposals were received.
- The low bid in the amount of \$26,550 was submitted by North Star Service of Southington. The second low bid was submitted by Perfect Temp of Plainville in the amount of \$26,562.
- Joe Alosso is recommending that Perfect Temp of Plainville be awarded the contract because they have been servicing the air conditioning units since 2003 with no increase in their hourly rates.

- Additionally, they have always been very responsive when problems occur. Finally, they are a Plainville company and the difference in the bid was only \$12.
- If the Town Council decides to accept the recommendation of the WPC Superintendent, the procedure would be to reject all of the bids that were received and then make a motion to waive the bid process and award the contract to Perfect Temp of Plainville in the amount of \$26,562.
- There is an item under New Business regarding this recommendation.

### Sale/Assignment of Tax Lien

- Several months ago the Town Council authorized the sale of tax liens for two properties owned by A. Aiudi & Sons located on Camp Street. The motion was contingent on an amount that was calculated through the end of March. For various reasons, including issues surrounding the COVID-19 Pandemic, that date of sale was not achieved.
- According to Atty. Mastrianni, the tax lien sale is ready to move forward this month. If the Town Council still wishes to move forward with the sale of the tax lien, a new motion needs to be considered as additional interest has accrued in the interim.
- There is an item under New Business that would authorize the sale of the tax liens on certain properties owned by A. Aiudi & Sons in the amount of \$302,397.64 through June 30, 2020. This is approximately \$14K more than what was previously approved.
- Town staff is recommending that the Town Council re-authorize the assignment of the tax liens with the increased amount.

### **CARES Act Grant**

- Recently the FAA announced that Robertson Airport was eligible to receive a \$30K grant through the CARES Act. The monies can be used for various purposes including operating expenses and maintenance items.
- In order to move forward the Town Council, acting as the governing body, must authorize the Town Manager to execute the grant on behalf of the Town.
- There is an item under New Business that would authorize the Town Manager to execute the CARES Act Grant Offer in the amount of \$30K for Robertson Airport.

### ClearGovProposal Recommendation

 A work session on the ClearGov Software System was held at the May 18, 2020 Town Council meeting. The mission statement for ClearGov includes: "to build a community of transparent, datadriven, modern governments... to help local governments

- operate more efficiently and communicate more effectively, fueling better strategic decision making and increased levels of community support".
- Town staff is recommending that the Town Council consider moving forward with the ClearGov Budget Suite and the ClearGov Insights Suite.
- The Annual Fee for these two programs is \$17,450. This includes a bundled savings of \$7,300 and the "set-up" fee is waived (\$7,200) if a contract is signed by June 30, 2020.
- Although this was not budgeted in the FY21 Budget, there are several options that could be utilized to move forward, if desired. In the current fiscal year there are monies available in the health insurance line item that could be utilized to pay for these programs. Other options include anticipated health insurance savings in the FY21 budget as well as making some adjustments to the CIP line item for the fiber project.
- None of the above recommendations would require any "additional appropriations" to the FY21 Budget. They may only require transfers.
- Additionally, my office currently has a graduate intern currently scheduled to work over the summer who could provide most of the time needed to implement/ input the necessary information to get the ClearGov Program up and running. This would allow for Town staff to continue their duties without a significant effort otherwise necessary if an intern was not available.
- In conclusion, the ClearGov Program would give the Plainville residents better transparency with respect to the budget, budget reporting and forecasting. Additionally, it would allow the Town Council to make better budgetary decisions as well by having easier to develop historical information and better forecasting techniques. Finally, such a program would make a more efficient use of town staff time in developing the monthly financial dashboard and the annual budget.
- There is an item under New Business regarding this recommendation.

### COVID-19 Update

- To date 160 confirmed cases of COVID-19 in Plainville out of 45,088 across the State.
- Plainville Library improvements need to be made to the inside of the building before it can be opened to the public. This will probably not occur until mid to late July. Services currently available to the residents will be discussed under "Happenings".

- The Berner Pool is scheduled to open this Saturday.
- The summer camp program is currently full with 30 campers for weeks 1 and 2 and 40 campers for the remaining weeks.

### **Financial Dashboard**

 The Dashboard was included in your meeting package and was posted on the Town website late last week.

### TAX AND ASSESSING

Tax bills were mailed out today, June 15th. Please note that there is no mill rate increase this year. For public safety, a self-addressed stamped envelope in included so residents can pay by mail. Also, if paying online by check, Webster bank has cancelled the electronic payment fee through October 31. If paying online by credit card, there will be a 3rd party fee that neither the town nor the bank can cancel. Finally, included with the tax bill is information about interest deferral.

### FIRE MARSHAL / EMERGENCY SERVICES

A reminder that CBIA's free PPE for small businesses, nonprofits and places of worship is continuing until supplies run out. ### TAX AND ASSESSING

Sewer bills are due June 1, 2020. If taxpayers have applied for the deferment program under the Governor's Executive Oder then the due date is August 1, 2020. Taxpayers can send their bills in by mail, deposit into the Dropbox outside, or pay online. ACH fees of \$1.50 per transaction have been waived by Webster Bank from now until October 31, 2020.

On April 20, 2020 the Plainville Town Council voted to adopt a deferral program for property tax relief during the COVID-19 pandemic. This program is an extended grace period program. What is "deferred" is not the tax but rather the last day to pay without interest. The deadline is deferred, not the tax. Eligible taxpayers are entitled to defer their payment deadline until 3 months from the tax due date, instead of the usual 30 days. An application is required for the deferment. The criteria to be eligible is as follows:

Resident: My household has suffered a reduction in income of at least 20% due to COVID-19. Since March 10, 2020, I have been either (1) been furloughed without pay; (2) had my hours significantly reduced; or (3) am unemployed. This has resulted in at least a 20% reduction in my household income.

Proof of Residency is attached (i.e. a copy of driver's license, utility bill, or other proof of residency)

Per the Governor's Executive Order 7S escrowed taxes are not eligible for the deferment.

# The following is chapter 1 of a series called "Incremental Islam," brief lessons on what non-Muslims need to know Park Park

Mohammed lived in Saudi Arabia in the 600's AD as a trader who claimed divine revelation from the angel Gabriel which was then recorded in the Koran.

When we think of religion we think of the Golden Rule, tolerance, love and forgiveness. Sharia law micro-manages daily life, from how to brush your teeth to how to treat women, gays and non-Muslims. When Muslims say that Islam is a religion of peace, they mean there will be peace when the whole world lives under Sharia law with no freedom of religion or freedom of speech. Contrary to what we're often told, Islam does not mean 'peace,' but rather 'submission' to the will of Allah.

Islam is a political, judicial and militaristic system made victorious by military expansion. The Islamic calendar begins with Mohammad's migration to Medina, Saudi Arabia. He was a peaceful preacher in Mecca, then in Medina he attacked trade caravans and killed many Jewish tribes, on the way to fulfilling his holy obligation to make Islam the only religion in the world. Mohammed called jihad the best action a Muslim can perform. "I have been ordered to wage war against mankind until they accept that there is no god but Allah and that they believe that I am His prophet..."

Muslims divide humanity into the house of Islam, and the house of war. Allah allows for acts of violence to propel Islam to power. The Koran says that Muslims are the 'best of created beings' while unbelievers are the 'most vile creatures,' removing empathy for non-Muslims.

Islam can never be questioned or criticized. Like treason, leaving Islam may be punishable by death.

### **INCREMENTAL ISLAM – 2**

The point must be made that these chapters on Islam are not intended to be critical of all Muslims, though they are highly critical of the ideology of Islam with its multifarious human rights abuses. Since Muslims may be killed for apostatizing (leaving Islam), it stands to reason that Muslims who believe in western freedoms may feel trapped within Islam.

Our initial chapters will endeavor to educate the reader on the hazards of electing Muslim legislators in non-Muslim countries. The failure of citizens of western countries to thoroughly understand this will lead to our demise as free countries. An excellent source of information on this subject is Islamic Doctrine Versus the U.S. Constitution: The Dilemma for Muslim Public Officials by Dr. Stephen Kirby, and a great resource for the truth of Islamic law is the Reliance of the Traveller.

First, Muslims are obligated to place sharia (Islamic law) above all manmade law so, when sharia conflicts with our Constitution, Muslim legislators will not choose the Constitution.

Second, Muslims are obligated to deceive non-Muslims whenever deception will help to reach an obligatory goal such as spreading Islam. Given the innumerable human rights abuses which are legal in Islam – death for apostasy, beating of wives, killing of gays, and so much more - honesty would almost never win converts. Imagine the damage done by this level of deception at work in our governmental bodies at all levels, from the local to the state and federal governments! Naturally, there are Muslims in the west who are here to escape sharia, not to spread it; given, though, that such a stance is entirely un-Islamic and would by viewed by Muslims as apostasy, how long would that legislator remain alive?

Our next chapter will discuss the problems presented by the First Amendment.

### Struggling

Normally I like to write a light, summer fun, enjoy nature and fresh fruits and vegetables article for this July/August edition.

This year is different ways that no one could have imagined. 2020 is a year of great struggle.

"We are all in this together" was shattered with the stark reality of the horrific 8 minute 46 second video that changed everything.

I'm outraged by the callousness of the deadly actions that literally squeezed the life from George Floyd. I can't wrap my head around what would make a person do such a heinous act.

Social media tends to tell us what to say, what to think and that the absence of our voice makes us part of the problem. I struggled with how to express my voice at this time.

I reached out to a friend, a black woman, to see how she was doing. Her words clarified for me the actions I need to take. The anxiousness in her voice made me realize just how long she has been subjected to racial injustice and how much it hurt. She was sad, angry and overwhelmed.

### Here is the advice she gave me:

- 1) Be open to call people out to address injustice. While everyone is entitled to their opinions, they are not entitled to encroach on others' basic rights. Be clear when actions or words are "not okay".
- 2) Reach out and ask, "what can I do". Be vulnerable.
- 3) Advocate on our behalf.
- 4) Understand who we are, our culture and our life of systemic racism.

Many years ago, I attended training on lean manufacturing from a Japanese consultant. The interpreter offered to give us a separate seminar on the culture of Japan. We had a sidebar on the lack of equality for the women on Japan. She told me something that I will never forget. "If you want to change the culture, you have to change the language".

It's not enough to have diversity training – believe me I attended many. It is the conversations, understanding and authentic actions we take that will make a difference. Black Lives Matter.

A Deadly Intersection on

### CT Roads

The period between Memorial Day and Labor Day has come to be known as the '100 Deadliest Days' because there is a sharp increase in the number of fatal crashes involving teen drivers.

But this year there is concern that, because of Covid-19, the risk could be even greater. The combination of schools closed, activities curtailed, summer jobs canceled, and restrictions being lifted could mean that young, inexperienced drivers are spending even more time behind the wheel – putting everyone else at greater risk.

More often than not, the victim of teen driver-involved fatal crashes is not the teen driver, but a passenger, someone in another vehicle, a pedestrian or a cyclist so this is an issue that impacts us all.

Even before the 100 Deadliest Days began, fatal crashes across the state were up more than 35% this year as compared to last year – despite there being far fewer drivers on the roads. State police cite speeding as a significant contributing factor.

The quarantine has been difficult for parents and teens but it is critical that our young drivers continue to abide by Connecticut's Graduated Driver Licensing laws. We have already seen the tragic consequences of not doing so.

"Parents remain the best line of defense to keep everyone safe behind the wheel," says Amy Parmenter, spokesperson for AAA in Greater Hartford. "It's never too soon to educate teens on the dangers of distracted driving, speeding, and the impairing effects of alcohol and marijuana. But we can't just tell teens about the dangers. We must also refrain from engaging in risky driving behaviors and ensure we are modeling good behavior."

### To keep roads safer this summer, AAA encourages parents to:

- Talk with teens early and often about abstaining from dangerous behavior behind the wheel, such as speeding, impairment and distracted driving.
- Teach by example, and minimize risky behavior when driving.
- Establish a parent-teen driving agreement that sets family rules for teen drivers.
- Conduct at least 50 hours of supervised practice driving with their teen.



# Replace the Primaries with Caucuses

On August, 11th the State of Connecticut and its 169 towns and cities will conduct the 2020 Presidential Primaries for both the Democrat and Republican Presidential Nominees. The State of Connecticut has a serious budget shortfall. Many Connecticut municipalities face daunting financial issues exacerbated by the Covid-19 crisis. Given that the outcome of the Presidential Primaries is already known having the General Assembly and Governor move Connecticut to a caucus system for the 2020 Presidential Primary election cycle would be a prudent financial move for the State budget and municipal budgets across

President Trump has garnered enough delegates to secure the Republican nomination for President. Former Massachusetts Governor William Weld withdrew from the race in mid-March when it became mathematically impossible to stop the President's renomination. Similarly former Vice-President Joe Biden has clinched the Democrat nomination achieving the number of required delegates this month. Former Vice-President Biden received the endorsement of his last rival for the nomination, Vermont Senator Bernie Sanders, in April when it became clear it was "virtually impossible" for anyone but Vice-President Biden to win the nomination.

The vast majority of down ballot races are also secure. The 5th Congressional District race is between Congresswoman Jahana Haves (D) and Republican challenger David X. Sullivan is set for the general election. The 31st Connecticut Senate general election will be between current State Senator Henri Martin (R) and Democrat challenger Mary Fortier. The 22nd House District has Representative William Petit (R) currently running unopposed in the general election. Why should the town of Plainville spend monies on a primary election that has already been decided? Numerous municipalities in the State face the same circumstances.

Given the unique situation the Covid-19 crisis has created financially for the State and the fact Governor Lamont has unilaterally postponed the Presidential Primary date twice to a date which effectively has already made the results of that primary irrelevant to the nominating process it would seem to be an undue burden to the taxpayers of municipalities to have elections that have literally no bearing upon the outcome of whom will be selected to run in the general election. The General Assembly by temporarily switching Connecticut to a caucus system for 2020 would save the taxpayers of the State millions of dollars and still allot Connecticut's delegates to the Democrat and Republican national conventions. It is an idea worth discussion and consideration.

Sadly when her husband Phil passed away three years ago Shirley poured herself into her job and received the help of her fellow workers, towns' people, friends and everyone she has formed a bond with for the past forty years. The job and those friends did indeed help her cushion her grief. Usually when an employee retires there is a retirement party but because of the virus the festivities will be postponed until a later date. Many people stopped by the Municipal Center on June 25th & 26th to wish her well.

The recipe was created by UConn Nutritional Sciences Intern Karley Krodel, July 2017. I have made these muffins and they are really delicious. I hope you will try and enjoy.

### Whole Wheat Strawberry Beet Muffins Makes 2 dozen

3 cups fresh strawberries

3 cups Big Y unsweetened applesauce

3 ½ cups whole wheat flour

½ cup Big Y granulated sugar

- 1 T. Big Y baking powder 2 large Big Y eggs
- 2 t. Big Y baking soda 1 t. Big Y vanilla extract
- 2 t. Big Y ground cinnamon 1 cup beets, grated
- 1 t. Big Y salt
- 1. PREHEAT oven to 350 degrees Fahrenheit and place cupcake liners in muffin tins.
- 2. RINSE and dice strawberries into small pieces, set
- 3. In medium bowl, MIX together flour, baking powder, baking soda, cinnamon and salt.
- 4. In a separate large bowl, COMBINE applesauce, sugar, eggs and vanilla. Stir in beets and all but about <sup>3</sup>/<sub>4</sub> cup strawberries(reserve for topping). NOTE: Smashing strawberries while mixing helps to release juices into the batter.
- 5. Slowly ADD dry ingredients to wet ingredients.
- 6. SPOON mixture into muffin tins, filling each cup <sup>3</sup>/<sub>4</sub> full. Top with reserved strawberries.
- 7. BAKE for 20 to 25 minutes, or until toothpick inserted into center of muffin comes out clean.
- 8. Let COOL in tins for 5 minutes. Remove and cool on wire rack completely before eating.

- Q-1) I have not had any Health Insurance for the last three years, and will be turning 65 in a few months. Will I have an Enrollment Penalty for not having previous
- A-1) No, but you will need to enroll in Medicare now that you are turning 65 to avoid any penalties.
- Q-2) My 65th Birthday was last month and I signed up and received my Medicare card. Is it too late to get an Advantage Plan?
- A-2) You can enroll in an Advantage Plan up to three months after your Medicare effective date. For example, if your Medicare Effective date was 6/1/2020, you can enroll in an Advantage plan up until the end of September. If you miss the date, you can enroll during the Annual Open Enrollment period (Oct 15 to Dec 7) with an effective date of January 1st.
- Q-3) I just received my Medicare card and do not take and prescriptions. Do I

have to buy a Drug Plan? I don't want to pay for something I don't need.

A-3) When you are enrolled in Medicare, you must have Credible Prescription coverage. If you don't want to pay for a stand alone drug plan, you may want to consider a \$0 Premium Advantage Plan that includes Drug coverage.

The Spanish flu, also known as the 1918 flu pandemic, was an unusually deadly influenza pandemic caused by the H1N1 influenza A virus. Lasting about 15 months from spring 1918 (northern hemisphere) to early summer1919,[3] [4] it infected 500 million people – about a third of the world's population at the time.[5] The death toll is estimated to have been anywhere from 17 million to 50 million, and possibly as high as 100 million, making it one of the deadliest pandemics in human history.[6]

In celebration of June as African American Music Appreciation Month, the Plainville Historical Society has posted a history of Plainville's African American Musicians and Bands on its web site at www.plainvillehistoricalsociety.com. The article is written by Gail Johnson Williams who is the Historical Society's specialist in local African American history. Gail is a Plainville native who has presented numerous programs related to the important role of the African American community in Plainville.

What is so special about her latest work is that as a noted musician, Gail herself is part of the story. Gail was a long-time member of Sam Kimble's band and was the only woman R&B electric bass player among area bands. In the 1990's, Gail founded Nzinga's Daughters which is a well-known women's group that has performed African and African American music.

In the article, Gail brings the world of local African American music alive. She tells of parties and music at the Halsted home on Pearl Street in the 1920's, George Peters' bands such as the Majestic Orchestra in the 20's and 30's, and Amateur Night at the Strand Movie theater in the center of town. Two legendary band leaders Sam Kimble and Bob Beverly (Royalaires and the Velvetones) are covered as are the musical connections with the A.M.E. Redeemer's Zion Church over the years. Gail also describes the story of Nzinga's Daughters and the message of social consciousness which has been woven into their songs and performances. The article concludes with a list of additional African American musicians from Plainville.

### St. Joseph Cemetery News

Also small stones that are used for decoration can become projectiles by the lawnmower and hit other workers or visitors that are in close vicinity.

These items have been placed at the back of the cemetery behind the green fence, where the shed is, for you to claim. Any broken items, old weathered plastic flowers and metal grave markers that have been greatly faded have been thrown away.

Born in New Brunswick, Canada on April 19,



Esther is accepted into the family and due to her hard work and determination becomes a favorite of Johann even over his own son, Aksel.
