

Once contacted a WPC Maintenance crew will be notified of the situation and will arrive to determine if the backup is from the main sewer line. If it is, they will clear

it. If the blockage is not in the main sewer line then the WPC Maintenance crew will direct the property owner to contact a local contractor.



Robert E. Lee, Town Manager's Report to Town Council May 3rd & May Meetings

Town Council Meeting May 3, 2021

CT Main Street Center – Patrick McMahon

- The FY22 Budget includes monies to join the CT Main Street Center.
 During the budget discussion,
 Town Council members had several questions regarding the benefits of joining the CT Main Street Center.
- Patrick McMahon, the Chief Executive Officer of the Center is here this evening to give a brief power point presentation of the organization and to answer any questions from the Town Council members.

Norton Park Pool Discussion for Summer 2021

- Recreation Director Courtney Hewitt is here this evening to discuss the plans for Norton Park Pool which is scheduled to open on June 12th. Courtney has suggested two options for residents to utilize the pool based upon the current COVID-19 restrictions that state that the employees should "limit the total number of patrons in the pool area and pool to the number of people/households that can safely fit on the [pool deck area while maintaining the six feet distance guidelines including 3 feet wide walking paths".
- With the size of the pool decks at Norton Park, this would limit the number of pool visitors to a maximum of 50 at any one time.
- She is suggesting two ideas on how the limit the capacity to best serve the Plainville residents. 1). Limit pool season passes to 400 on a first-come, first serve basis and 2). Sell tickets daily for \$2 each on a first-come, first-serve basis until the capacity is reached.
- Courtney is seeking Town Council feedback on each of these suggestions.

Police Body Camera Discussion

- Last summer the Police Reform Bill was signed into law in Connecticut. That law requires that all police departments in the state to have body and in-dash cameras by July 1, 2022. The Plainville Police Department has had in-dash cameras for several years.
- Before Chief Catania passed away, he was in the process of putting together a recommendation for the purchase of body cameras for the Department. Lt. Peterson and Lt. Mullins have continued this effort and are prepared to move forward with the purchase and implementation of body cameras for the police officers.
- They are suggesting two options:
 1). Outright purchase of the system from Watchguard or 2).
 Enter a Managed Care Plan. The Managed Care Plan would save approximately \$26K over a five-year period.
- year period.

 Lt, Peterson & Lt. Mullins will

give a brief presentation of the Watchguard system and the policy regarding the use of body cameras issued by the Police Officer Standards & Training Council and to answer any questions from Town Council members. They are seeking Town Council input on which option to pursue. No action is being requested this evening.

Valley Water/Aquarion Water Company Acquisition

- Valley Water recently notified the Town that their parent company, New England Service Company, has entered an "Agreement and Plan of Merger" with the Aquarion Water Company of Bridgeport. Subsequently, on April 21, 2021, Valley Water sent a letter to the Public Utilities Regulatory Authority (PURA) requesting that their current application for a rate increase be "temporarily suspended" until such time as the merger is approved by the required regulatory agencies in CT, MASS., and NH.
- Valley Water is estimating that the approvals can take from three to six months. Valley Water is also proposing that they "initiate discussions among the parties and report back to PURA...if a settlement is achievable" with regards to their proposed increase.
- I recently met with the President of Aquarion and Valley Water representatives in which they expressed their interest in negotiating a rate increase rather than having PURA make the decision. I told them that I would be willing to participate in such discussions.

Standard & Poor's Rating

- On April 22nd, S&P re-affirmed Plainville's Bond Rating of AA+. This is one notch lower than a AAA rating which is the highest rating a Town can attain. They also stated that the financial outlook for Plainville is "stable".
- In their report, S&P noted that it "reflects a strong growing residential and commercial base" and that "lending further stability to the rating and the outlook are" Plainville's "very strong liquidity and stable revenue mix, with the predominant revenue stream of property taxes, with collections remaining strong".
- They also noted that Plainville has "strong management, with good financial policies and practices", "strong budgetary performance", "very strong budgetary flexibility, with an available fund balance in FY 2020 of 18% of operating expenditures".
- They also noted that the Town has "very strong debt and contingent liability profile with debt service carrying charges at 7.6% of expenditures...with 66.7% of debt scheduled to be retired in 10 years". They also recognized that the Town Council recently adopted a fund balance policy.

- In conclusion, S&P stated that Plainville has a "strong economy", "strong management", "strong budgetary performance", "very strong budgetary flexibility", "very strong liquidity", and "very strong debt and contingent liability profile".
- As the Town Manager I am proud that Standard & Poor has recognized the efforts of the Town Council and Town staff to achieve a financial record that earned a Bond Rating of AA+.

All Day Budget Vote Results – FY 2022

- On April 27th both the General Government and Board of Education Budgets were overwhelmingly approved by those who voted. The General Government Budget was approved by 81% of those who voted (377, yes 90, no). The Board of Education Budget was approved by 77% of those who voted (359, yes 106, no)
- The next step in the process is for the Town Council to set the mill rate. The Appropriation and Finance Committees of the State legislature recently issued their recommended State Budget for the next two fiscal years. Their recommendations restored the phase-in of the ECS formula. That phase-in would result in an additional \$198,930 above what was originally anticipated.
- This increase in ECS monies would reduce the mill rate increase to 0.09 mills or 0.25% increase in taxes based upon earlier revenue discussions. This is \$129,801 from a no tax increase. It is recommended that the Town Council consider setting the mill rate at the May 17th meeting.

FAA Grant Agreement

- Several months ago, the F.A.A. notified the Town that the Town would receive \$13K from the Airport Coronavirus Response Grant Program for Robertson Airport. To receive the grant, the Town Council must provide authority to execute the grant to the individual signing the grant.
- There is an item under New Business that would authorize the Town Manager to be the authorized representative for the Town.

Open Burning Ordinance Discussion

- The Open Burning Ordinance was adopted on November 6, 2006. The purpose of the Ordinance is to require that a permit be issued by the Fire Marshal or the Open Burning Official before any person initiates open burning in any public or private area outside of a building.
- Fire Marshal Ron Dievert is requesting that the Town Council consider amending Section 219-9 E (3) to comply with updated D.E.E.P. danger levels.
- Specifically, the current language allows for the revocation of an open burning permit in the case of "extreme or high forest fire danger".
 D.E.E.P. has added a third level,

namely, "very high" fire danger.

- The Fire Marshal is requesting that Section 219-9 E (3) include "very high" as one of the levels now recognized by the State for measuring fire danger. The proposed language would read: "An extreme, very high, or high forest fire danger exists".
- If the Town Council is agreeable to this suggestion the next step would be to schedule of Public Hearing to solicit comments from residents before considering action.

Auditor Appointment

- Each year the Town Council is required to appoint the firm to conduct the annual Town audit. For many years, the Town Council has appointed Blum Shapiro of West Hartford to perform this work. Last December Blum Shapiro announced that they were joining the national professional services firm of Clifton, Larson & Allen, LLP.
- The Blum Shapiro "team" will continue to serve clients locally from their location in West Hartford. Town staff is recommending that the Town Council appoint CliftonLarsonAllen LLP to perform the FY21 Town Audit. There is an item under New Business regarding this recommendation.

COVID-19 Update

 Health Director Shane Lockwood is here this evening to give an update the latest statis of the COVID-19 restrictions and to discuss what may be expected going forward in the coming months.

Town Council Meeting May 17, 2021

GE Request for Monitoring Wells in Town ROW

- General Electric is requesting approval for the installation of groundwater monitoring wells in Town rights of way to support ongoing remedial activities associated with the former GE facilities located at 10 New Britain Ave. and 41 Woodford Ave.
- G.E. is remediating groundwater on these properties under the oversight of the CT DEEP. Arcadis U.S., Inc. has been performing that work on behalf of G.E. As part of their ongoing remediation activities, due to the detection of chlorinated solvents at concentrations slightly greater than CT DEEP standards, it is necessary that environmental testing occur at locations beyond the former GE property boundaries to meet CT DEEP requirements.
- G.E. is requesting access to install and sample groundwater monitoring wells at two locations within Town rights of way along roadways.

- The wells would be 120 feet deep, with a borehole that is approximately 12 inches in diameter and enclosed with flushmount well covers set inside an approximately 2-foot by 2-foot concrete pad and secured with a lock and expandable plug.
- Quarterly groundwater samples would be taken, and they anticipate doing this for approximately two years. The location of the two wells would be on Norton Place and Jefferson Street. G.E. is also planning to install a third monitoring well on east side of Farmington Ave. (State Road) just north of the Route 72 overpass.
- There is an item under New Business that would authorize the Town Manager to execute the Right of Entry Agreement with G.E. to install the two monitoring wells in the Town R.O.W.

Refunding of Clean Water Fund Loans

- The Town recently sold General Obligation Bonds to pay off four Clean Water Fund Loans to the State of CT totaling \$10,050,000. These loans were borrowed in 2006, 2009, 2010 and 2012 and were used to make improvements to the wastewater treatment plant located at the end of Cronk Road.
- The interest rate on those loans were at 2%. As a result of the bond sale, the Town will be able to lower the interest rate on the remaining years of the bond from 2% to 0.68%.
- The overall Gross (Budgetary) Savings through FY21 to FY30 is \$521,757. These Savings will be in the sewer fund. The sewer fund will save \$206,552 in the current fiscal year (FY21) as the Town will not have to make future Clean Water Fund payments. The Town will save an average of \$35K over the remaining nine years of the loan.
- These savings will assist in helping to minimize future sewer user charge increases.

FY2022 Mill Rate Discussion

- Since the budget has been approved at the All-Day vote, several Town Council members have expressed a desire to consider a "no tax increase" when the mill rate is set. This would entail adjusting revenues by \$317,639 to attain a zero mill increase. Since the April 5th Town Council meeting, the State Legislative Committees have brought forth their recommended budget which is expected to be acted upon by the end of the Legislative Session on June 5th.
- Based upon news reports and several CCM meetings (which included key legislative participants), there is strong support to restore the phase-in

- of the ECS formula. This would result in \$192,639 in additional revenue to support the FY22 budget leaving \$125,000 to attain a "no tax increase".
- Town staff (Rob Buden, Matt Daskal, and I) discussed several alternatives for consideration regarding the setting of the mill rate. They are:
- 1. Set the mill rate at 34.71. This would result in a mill rate increase of 0.09 mills or 0.25% increase in taxes.
- 2. Set the mill rate at 34.62 (current mill rate) by increasing the Unassigned Fund Balance Contribution from \$400K to \$525K. (+\$125K)
- 3. Set the mill rate at 34.62 (current mill rate) by increasing the following revenue line items: Building Permit Fees +\$50K; Police Fees +\$20K; Recording Fees +5K; Unassigned Fund Balance +50K.
- Please note that revaluation is currently underway for the October 1, 2021 Grand List. It is anticipated that the Grand List will increase - meaning that the mill rate will decrease- based upon all other factors staying the same (i.e., revenues and expenditures). However, the impact on the different types of taxable categories could shift depending upon the changes to industrial & commercial property, residential property, motor vehicles and personal property. In other words, all taxable property during a revaluation year will have a different tax change (increase or decrease) based upon their relative change in value.

Concessions Bid

- Each year the Town solicits bids for ice cream and concession services in the Town's parks. This bid provides for a minimum \$550.00 payment by the vendor for the right to sell in the Town's Parks. The bid also includes provisions that allow the Town to limit vending during special events (example a youth organization fundraiser).
- Due to the pandemic the Town did not seek vendors during the summer of 2020. This year's solicitation resulted in one bid- from the 2019 vendor Two Brothers Ice Cream.
- Town staff is recommending that the Town Council award Plainville Bid# 2021-20 Town Park Ice Cream and Concession Rights to Two Brothers Ice Cream of Waterbury, Connecticut in the amount of \$601.00. There is an item under New Business regarding this recommendation.

COVID-19 Update

• Connecticut's seven-day COVID positivity rate had dropped below 2% for the first time in six months. The state also became the first in the nation to fully vaccinate 50% of its adult population. Governor Lamont's emergency orders regarding the

- COVID-19 pandemic are scheduled to expire on May 20th.
- Last week the State Senate and State House granted final legislative approval for another extension of the Governor's emergency COVIOD-19 powers until July 20th. It is unclear at this time whether the indoor mask mandate will remain in place.
- Additionally, late last week FDA approved COVID-19 vaccinations for children between 12 and 15 years of age. The CDC has stated that fully vaccinated people can largely ditch wearing masks indoors, however, the Governor's emergency orders require them to be worn indoors at least until May 20th. The CDC guidance still requires wearing masks in crowded indoor settings.
- The Municipal Center will allow people to enter without a mask if they are fully vaccinated according to the CDC Guidelines beginning this Wednesday. Notices will be displayed on the entryways to the building. People will be asked to comply via the "honor system".

Mountainview Pump Station Improvements

- The FY22 Capital Improvement Budget includes \$82,010 to replace the two pumps at the Mountainview Pump Station plus a spare pump.
- Superintendent Joseph Alosso is recommending that they purchase the pumps directly from Fleet Associates in the amount of \$63,407 and have them installed by Blake Equipment for \$11,950. The WPC has Fleet Pumps at the other pump stations in Plainville.
- The total cost for the replacement and installation is \$75,357. There is an item under New Business that would waive the bid process and authorize the purchase of the pumps for the Mountainview Pump Station in the amount of \$63,407 from Fleet Associates of White Plains.

Financial Dashboard

The Financial Dashboard for the period through April 30, 2021 has been included in the meeting package and has been posted on the Town website.

Plainville Performs Assessments of Sidewalks in the Town.

The Town of Plainville recently completed a sidewalk condition assessment on 64 miles of walkways in Town. Late last year the Town Council authorized a contract with StreetScan to utilize ScanCarts to conduct the sidewalk assessments. These carts were outfitted with 2D and 3D cameras.

Once this information was collected, StreetScan developed a "Sidewalk Condition Index (SCI)" which ranked the overall health of the sidewalk segments on a scale of 0 (worst) to 100 (best). The SCI considers tripping hazards, surface distortions, uplift, and cracks. There are seven levels in the sidewalk condition index ranging from Excellent to Failed. The good news is that the average SCI of all the sidewalks in Plainville is 81. That score means that most of the 64 miles of sidewalk are considered "good". The bad news is that 2.61 miles of sidewalk are rated in "serious" or "very poor" condition.

The program also provides cost estimates to fix the sidewalks. This is very helpful when putting together the annual Capital Improvement Plan or when applying for available grants.

At a recent Town Council meeting, Town staff gave a demonstration of the new program. Chairwoman Katherine Pugliese remarked that "this is a very useful tool that will make it easier to prioritize which sidewalks need to be addressed first. It also gives the Town Council the ability to view the condition of sidewalks remotely with our computers."

Now that this project has been completed, the Town Council expressed their support for a systematic replacement of those sidewalks with low SCI scores. "This may take several years, but it's a start and a commitment that it is time to devote some resources to these valuable assets that allow for our residents to safely walk throughout Plainville", remarked Chair Pugliese.

This summer the Town will be replacing sidewalks on Laurel Court and a portion of Tomlinson Ave. near the High School. Next year the focus will begin in the Northwest section of town where there are many streets that have a low sidewalk condition index number.

To Your Health

It's time for FUN!

Not that zoom meetings, balancing working from home with 4 other people in the same space, slow internet, and forgetting your mask just as you get to the door of the supermarket isn't fun. There are ups and downs to everything. June provides us the gifts of longer days, warmer temperatures, gardening, fresh vegetables and open trails. There are literally no-excuses to get out of your chair and enjoy the outdoors, breathe in clean air and sunshine and feel invigorated, even for only 30 minutes.

However, if you are feeling achy,

sluggish, heavy and have lots of

digestive issues, you may not be feeling

up to the rewards of fun. Perhaps these ailments can be resolved when you make a modification to what you eat. As you know, I believe that nature provides what we need for health and vitality. In fact, I just finished a 4 week long "The Art of Eating" program. This is similar to what you might know as a detox or elimination diet. The name was changed by the founder of The Institute of Sustainable Nutrition, tiosn. com, because this process of added focus on what to eat and how to eat mindfully and appreciatively, helps to create the habits that will last longer than the program. The Art of Eating is a call to add in foods that are known to provide the nutrients we need and remove foods that create inflammation and don't add value to our health. The heavy hitters in this regard are sugar, including artificial sugars, sodas, corn and soy unhealthy fats, and processed foods. Gluten, eggs, and dairy, while not bad are the typical foods that cause food sensitives in many. By eliminating these and then adding them back in one at a time can help to identify if these culprits need to say out of your diet a little longer. The key is to listen to



what your body is telling you.

Anyway. I realized that I was

Anyway, I realized that I was eating way too many baked goods, bread and sweets over the winter and needed the structure of a group to help me reduce cravings and get back on track.

So, my journey starting with adding in simple soups, such as leek and lentil to transition from heavier meals. Delicious salads included chicken and or salmon. Frequently beets were incorporated to salads and smoothies as they support the liver to remove toxins. Brown rice replaced white potatoes. Avocados are a healthy fat option that can be added to salads or alone as a dip with carrots. Sauerkraut or other fermented foods provide the probiotics to help keep our microbiomes in balance which supports our immune system and aids in digestion. Oatmeal replaced a slice of coffee cake and I added chia seeds, almond milk, cinnamon and fruit to include more food groups and to feel full longer. Sometimes breakfast was the leftovers from last night's dinner. I returned to my normal routine of one small dark chocolate square instead of a handful of cookies to hold off the sugar blues. After dinner, herbal teas helped to relax me.

At the end of this program, I felt lighter – 5 lbs. in fact. I also found my cravings declined and can be satisfied by reaching for an apple, pear or banana with some nut butter. Best of all, my sleep and energy levels improved. I'm back working out at the YMCA.

My goal in sharing this is to remind you to pay attention to what you are eating and how it makes you feel, i.e., sluggish and bloated and never quite full or satisfied. Would you be willing to incorporate more healthy options in order for improved vitality and more fun into your life? It takes some planning and willpower at first, but over time, it becomes your own new art of eating. If you are interested in tackling this, send me an email and I'll forward my "Listen to your Gut" handout to help you get started.

I want to always caution those with health concerns to check in with their physician prior to making any significant dietary changes, especially if you are on medications that could be impacted. *Stay Healthy, Enjoy June!*

-1) I have a Delayed Enrollment for Part B, because I worked until age 68. Do I have to do anything besides have my Employer complete the Employee Verification Form?

A-1) If you have not yet applied for Part A, you will need to apply for BOTH Part A & B AND complete the Employer Verification Form. If you already have Part A, then you will need to Apply for Part B along with sending in the Employee Verification Form. They PREFER that you send both Forms together. CMS-40B "Application for Part B Enrollment" and the CMS-L564 "Request for Employment Information"

Q-2) I am going to sign up for Medicare soon and I do not take any Prescription Drugs. Do have to sign up for a Plan with Drug coverage? I read that it is 'optional'.

A-2) If you do not have 'Credible' Prescription Drug coverage when you are enrolled in Medicare, and then in the future decide to get a Drug Plan, you will likely be subject to a Penalty for the number of months that you were not enrolled in a Drug Plan. This Penalty is added to your Drug Plan Premium for the remaining time you are enrolled in Medicare.

Q-3) What is the BEST Advantage Plan I can enroll in in Connecticut?

Senator Henri Martin (R-31) Spoke in Opposition to HB 6423



HB 6423 eliminates parental rights to make health choices for their children by requiring vaccinations in order to enroll in school in Connecticut.

Senator Martin shared the following statement after the vote:

"Personal choice and a parent's right to choose for their family are of paramount importance and even through the hours of debate today, there was never an adequate rationale presented as to why this policy change is needed and much less as to why it is needed now.

"While the government does have the right to step in when it comes to matters of protecting public safety, the data that I have seen does not indicate that we are actually in an emergency situation at present. A child's education is not worth jeopardizing nor is infringing on parent's rights if there is not a considerable improvement generated by this policy change.

"It is my hope that in the future that this legislative body will properly consider if the benefits of the measures they propose are actually worth the peripheral ramifications they may cause."

Last week, the House voted on a 'Resolution Approving An Amendment To The State Constitution To Allow For Early Voting.'

I wanted to share with you some of my feelings on this bill after discussions with town clerks, hearing from many of you, and to also provide you with an explanation as to why I chose at the present time to vote against this

Voting is a right and privilege. As such, one must make some effort in order to exercise that sacred right. Prior to the legislature voting on the 2021 early voting bill, Connecticut's previous laws allowed for 31 days to register for an absentee ballot along with 14 hours to vote on election day. Due to the COVID pandemic, voting options were extended to include no-excuse absentee voting for everyone. The legislature also a bill has under consideration to continue no-excuse absentee voting into the future.

The resolution approving 'An Amendment To The State Constitution to Allow for Early Voting' brought before the legislature last week was sure to pass. Given the makeup of the legislature, where the majority party has 96 members, only 76 'yes' votes were needed to place this proposal on the November 2022 ballot.

During the debate, much of the discussion on this bill centered around convenience and not the responsibility and efforts we all must make in order to evaluate our choices and vote for the candidate or issue of our choosing.

I had several concerns with this bill, many of which deal with ballot security, costs, administrative staffing, the number of days that will/should be allowed for voting, etc.

For early voting the state association of the clerks prefer in person voting at a designated site, with ID required. The ballot would then be filled out by each voter and then placed into the machine. After discussions with several town clerks, if the prior suggestions could not be accommodated, they could be comfortable with the no-excuse absentee voting bill with appropriate safeguards and clean maintenance of voter rolls. This should make the process convenient for everyone while being relatively reasonable to administer.

Given these uncertainties, concerns from town clerks, and constituents who contacted me (2:1 opposition), I voted no. If residents of CT pass this change in the 2022 election (this will be on the ballot as a question to amend the CT constitution for all to vote on) it will be returned to the legislature in the 2023 legislative session to design the specific framework. If at that time we can ensure security, and it's a process the Town Clerks can fairly administer, I will fully support this change in the future.

Now the fate of this option lies in the hands of residents to decide if they want this major constitutional change in 2022.

Rep. Petit Co-Sponsors Bill to Remove Race **Designation from Marriage Licenses and Land Records**

HARTFORD – State Representative William A. Petit Jr. (R-22) voted Tuesday in favor a bill proposal that according to the representative, would seek to correct several historical wrongs that have been embedded in the state's constitution for generations.

The proposal, HB-6665, An Act Concerning the Removal of Restrictive Covenants Based on Race and Elimination of the Race Designation on Marriage Licenses, would prohibit restrictive covenants - defined as "an instrument affecting the title to real property that purports to restrict ownership or occupancy of such real property on the basis of race."

"This bill will strike racist language from our covenants and marriage certificates and correct a long overdue wrong," Rep. Petit said.

According to the bill, by December 1, 2021, the Office of Policy and Management must develop a standardized form to report unlawful restrictive covenants, town clerks must make such forms available on a munici websites where land records are kept, along with posting a notice informing the public of the provisions of this section in the town clerk's office where land records are kept.

Current state law requires applicants provide their race or face having their application denied. Despite the Department of Public Health collecting this information, it does not serve any intended purpose. HB-6665 would therefore eliminate applicants from being required to provide race as a requirement for approval. Connecticut is only one of eight states that requires couples to identify

their race before obtaining a marriage license. The bill received unanimous support from the House and will now move onto

PROTECTIVE ORDERS IN CONNECTICUT

Relationships can be great for people in any number of ways. One way or another we all have relationships. However, that does not mean they're all going to be good and that is when the need for a protective order may arise. Thankfully, the law affords both criminal and civil actions to be taken for the victims. So, in the event the police are not willing to do anything, potential victims may still secure their safety through a civil order.

Connecticut judges have the authority to issue protective orders in domestic violence cases directly from the bench when the case is brought before them. These protective orders may be a full no contact, limited contact or an order not to threaten, harass and/or otherwise assault the victim. When speaking directly about domestic relationships these protective orders may issue against each party. The degree of the contact permitted is up to the judge when presented with all of the evidence from the various parties and state departments. If a partial protective order is issued Connecticut law may not require in-person contact to constitute a violation of the order. Electronic mediums, like Facebook or email, may be used as a violation as well as telephones and other like instruments. The penalty for such a violation may be up to 5 years in prison and a \$5,000 fine. Therefore,

regardless of a person's intent or lack of direct contact with the victim they may be guilty of violating a criminal protective order issued by a judge.

A criminal protective order ultimately needs to be before a criminal court, which forces potential victims to wait for a crime to be committed. So what can you do if the police have nothing immediate to act on and you only have your suspicions and concerns? Victims can bring an ex parte request for a civil protective order. "Ex parte" means that neither party has to be present in order for the judge to grant a protective order to the applicant. If granted, the order provides the victim with a means for having the accused held criminally liable for placing them in physical fear as long as the accused violates the contact requirements implemented in the ex parte order. Ultimately, nothing can assure everyone's complete safety, yet civil protective orders provide people with an avenue for enhancing their safety without being forced to leave it to the police.

So whether you are in the happiest domestic relationship in the world or not, be sure to be prepared because people change and things may go south in a hurry. Knowing how the law can work to protect you may make all the difference.

Crowns



Elections Have Consequences: The Biden Administration After 100 Days

The first 100 days of a Presidential Administration has become a means to analyze the success or failure of a new President in implementing their The incoming Roosevelt Administration set the standard with their flurry of policies to deal with the Great Depression upon settling into the White House 1933. For practical purposes a new administration has until Congress' recess at the Memorial Day holiday weekend to use its political capital from the previous election to move their agenda through Congress and to establish how it will react to the inevitable crises and foreign policy issues hopefully providing a calm and steady hand on the tiller of the ship of state. The Biden Administration has passed the 100 day mark providing political opponents, supporters, and foreign powers a view of how this administration will function over the next three plus years.

On day one in office President Biden revoked the permit for the XL Pipeline. The pipeline would have brought additional oil from the Canada for refining in the United States. Estimates have varied on how many potential American jobs were lost by this action from about 8,000 to 28,000. For TC Energy (formerly TransCanada) 1,000 jobs were cut immediately. Canadian

Minister Prime Justin Trudeau "disappointed" in President Biden's decision and had received no communication regarding it prior to the Biden Administration announcing the policy change which had a major economic impact on America's neighbor to its north. The cancelling of the XL Pipeline combined with the Biden Administration's halting of future oil and gas leases on Federal land (essentially the majority of land West of the Mississippi) both point to lower future American energy production and have fueled the rise in oil future prices based on projected diminished American oil and gas production. Though how much these decisions have increased the price at the pump is open to debate among economists, the rise in oil futures and the price of crude oil has been swift and rapid during the Biden Administration.

The increase in oil prices has been mirrored by an increase in inflation. The Biden Administration's push for more spending, the \$4 trillion "Infrastructure" Bill, continued quantitative easing, and other expensive social programs has indicated to the markets the deficits and debt will rule this Administration even more than prior ones. The dangers of wanton spending and debasement of the currency, which is essentially what quantitative easing is, have always ended poorly for any government that does such things for too long. Promoting an "Infrastructure" Bill in which only around 20 cents on each dollar spent is actually appropriated for actual infrastructure projects (building and fixing roads, rails, airports, etc.) is a quick path to insolvency and weakens the buying power of the dollar. A number of economists are warning of a return to 1970's style inflation.

Inflation has been referred to a one of the cruelest "taxes" and the Biden Administration has proposed a slew of higher taxes to take more money out of the economy while inflation erodes the dollar's purchasing power. A definite two punch combo to working and middle-class Americans.

While higher gas prices are hitting the wallet, cyber attacks are shutting down critical infrastructure. The Colonial gas pipeline was hit with a cyber-attack closing it down. Gas shortages rocked the inland South especially in Georgia and North Carolina. A number of foreign policy analysts have noted the world seems to be engaged in a cyber-world war. Australia has been repeatedly attacked as has the United States. In the first major salvo during the Biden Administration a near \$5 million ransom was paid. It has long been the American position that the United States does not pay or even negotiate with terrorists. The moral hazard of paying off the terrorist only fuels more like attacks. The payment to Darkside, the group that instigated the hack, is problematic even if, as Barron's reports, the denial of service attack on Darkside and disappearance of their funds was a U.S. cyber-ops action, since the payment was widely reported and will likely encourage more rouge activity.

The Biden Administration's proclivity to payoff American enemies in lieu of standing resolutely in defense of American interests is reaping a bitter harvest in the Middle East already. Monetary enticements, along with the withdrawal of support for the Yemeni government in its fight against the Iranian supported Houthi movement, to bring Iran back into the flawed nuclear deal agreed to by the Obama

Administration has essentially set the Middle East on fire. Iran is actively sending arms to the rebels in Yemen. a poor but strategically important country as it controls access from the Gulf of Aden to the Red Sea and eventually the Suez Canal. An Iranian proxy state there could easily shut the flow of commerce from Asia to Europe and beyond. Iran has supported Hamas and is actively doing so while Hamas has once again attacked Israel with indiscriminate missile attacks. The relative peace and quiet of the Middle East brought on by the Abraham Accords of the last Administration has been laid in tatters after only a few months of appeasement of Iran by the Biden Administration.

The first months of a Presidential Administration sets the tone for that administration for its first term. The Biden Administration has through its own policies set troubling precedents in economic policy and foreign policy. Even more problematic than bad policy is no policy as is the current case on the border. Even loyal yellow dog Democrats in the states along the Mexican border are calling out the Biden Administration for having no workable policies and the administration's refusal to even acknowledge the problem. The first 100 days of the Biden Administration have come and gone. Since most Presidential successes of any Administration occur in that early span of time one can only ponder what the next three plus years will

The American public will have to live with the consequences because elections have consequences and don't have doovers.

It's predicted that cars will change more in the next five to 10 years than they have over the past 50. The driving forces behind the changes are improving road safety, lowering emissions and taking some of the stress out of driving.

Some advances will be tied in with the increased uptake of electric cars, but the biggest influences will be automated driving technologies and connectedness. These are set to transform the whole driving experience.

Safety testing body Euro NCAP is pushing ahead with its Vision Zero ambition to stop people from dying on the road. In doing so, it has set out a timeline for 2020-2025 of when it will start testing a range of new technologies.

In 2020, the body started testing automatic emergency steering, driver monitoring systems and automatic emergency braking systems that work at junctions and when you're reversing out of a parking space. You can find many of these technologies on the most modern cars right now, because they're necessary to gain Euro NCAP's full five-star safety rating, an accolade that every mainstream car maker strives for.

Future technology

In the near future, though, cars won't only be able to protect people from harm; they'll also be capable of giving you lots of useful, real-time information. For example, you'll be able to ask the car to find you a restaurant, reserve you a parking spot nearby and then give you directions to get there. And if your car is driving autonomously, it could even project a three-dimensional digital avatar to keep you company.

More than half of the cars in the world are already connected to the internet, and future vehicles will also communicate with each other, road infrastructure, intelligent junctions and smart street lamps in a network known as the Internet of Things. Your car will be able to use all the information that these upload to give you advance warning of any potential hazards or hold-ups along your chosen route. In short, driving will become smarter and safer than ever before, with less time spent in traffic jams.

Safety-enhancing systems

1. Virtual door mirrors

Instead of mirrors, there's a camera on each side of the car that sends live footage to screens in the corners of the dashboard or in the doors. These cameras generate less wind noise and aerodynamic drag (important for the range of electric cars), minimise blindspots and provide a clearer view in poor weather conditions.

The cameras automatically alter their view to cope with motorway driving, cornering and parking, and if the screens are touch-sensitive, the driver can use his or her fingers to zoom in to see specific areas in more detail.

Future technology

When can I have them? Lexus became the first to use this technology in late 2018 on the ES executive saloon. However, it offers this only in Japan, so our first taste came with the Audi E-tron electric SUV, which began offering virtual door mirrors earlier this year as a £1250 option. They're standard on the Honda E small car, too.

2. Digital rear-view mirror

At the flick of a switch, the rearview mirror can be turned into a high-definition screen showing an extrawide (50deg) view of the road behind. This eliminates the usual blindspots and the problem of the driver being unable to see properly past tall passengers or bulky luggage in the back.

Furthermore, a digital rear-view mirror provides better visibility in low light than a conventional mirror and is angled so that reflections don't adversely affect your view.

When can I have it? Although digital rear-view mirrors started appearing on concept cars many years ago, they didn't hit the market until 2016, on the Cadillac CT6 luxury saloon. Mainstream availability came only recently, through Jaguar Land Rover's second-generation Range Rover Evoque, facelifted Jaguar XE and the 2021 version of the Range Rover Velar.





A teenage murder witness finds himself pursued by twin assassins in the Montana wilderness with a survival expert tasked with protecting him -- and a forest fire threatening to consume them all. imdb

Angelina Jolie bursts back into the action genre as Hannah, a smoke jumper relegated to tower duty after suffering an emotional breakdown caused by a misguided decision that cost three children their lives in a raging fire. The film may lack some clarity in its exposition of the events that lead up to the events that lead young Connor (Finn Litlle) to become the target of two well trained assassins but it provides enough visceral thrills to more than compensate for that oversight. It has something to do with his forensic accountant father, Owen Cassidy,(Jake Weber) having done the right thing which will have the effect of bringing down some heavyweights in politics and law enforcement. We are never afforded the opportunity of exactly what this tidbit of evidence is but judging by the reaction and the force behind taking him out it is substantial. Taylor Sheridan, usually a dependable scripter (Hell or High Water) falters with this one but proves the adept director of


an action thriller as he has shown in the past (Wind River).

And what an absolute pleasure it is to find Jolie in top form as the ass kicking but vulnerable action star she has mastered in the past. She effectively conveys the torment of the responsibility of making a judgement call regarding the direction the path of a blaze will go only to have it change directions trapping three children and engulfing them in the deadly flames. On the surface she remains the unpredictable firecracker on the team, displaying the type of behavior one would attribute to somewhat of a death wish.

The rudimentary plot, such as it is, has the accountant with son in tow fleeing to the survival training camp run by the area sheriff, Ethan (Jon Bernthal) and his pregnant wife, Allison (Medina Senghore) for refuge. As luck would have it, Ethan is Cassidy's brother-inlaw as well as Hannah's ex-boyfriend. Their journey is interrupted by professional assassin brothers Patrick (Nicholas Hoult) and Jack (Aiden Gillan) Blackwell. They successfully take out the accountant but not before he manages to give his son the damning evidence and force him to abandon him and run for his life. The Blackwell's know they must eliminate the boy as well and start a forest fire to keep the local authorities busy. Though this stretches credulity, the visual effects created for the uncontrollable blaze are amazingly realistic and provide a thrilling background for the cat and mouse chase involving Connor, whom Hannah has discovered lost in the woods and taken under her protective wings, and the cold heartless killers..

The scenes between Hannah and Connor are among the films best as Hannah's need for redemption kicks in and Connor's need for an adult figure he can trust bolster the growing bond between the two. Finn Little gives a truly compelling performance that is a comfortable fit with Jolie's complexity. There is genuine warmth between the two that keeps us on the edge of our seats as they traverse the blanketing flames that surround them and the deadly duo that pursues them.

This lean, mean thriller has fine performances by the supporting cast. Hoult and Gillan have ice in their



veins as the hired assassins while Senghore is a scene stealer as the resourceful survivalist.

The film is flawed but it delivers in the action, thrill ride category. And it is a perfect fit as a star vehicle for the amazing Jolie.

Hi, neighbors. Well, technically, we aren't neighbors as I now live way up in the northwest corner of the state. I did, however, spend my formative years

and then some right next door to Plainville in the Hardware City, New Britain. I was a frequent visitor to Plainville attending events at the Plainville Stadium and of course, enjoying movies at the Plainville Drive In. Let me introduce myself. I'm your friendly neighborhood film critic, Robert James O'Dell, and I thought you might want to learn a bit more about me. If you don't, read no further but if you have a dollop of curiosity about the thought process of the fella who has been providing critical analysis of films in your local monthly newspaper, read on.

I owe my love of the movies to my mom. She loved films. Of course, in my youngest movie going days, we attended as a family, mom, dad, sister, brother and the baby of the family, yours truly. As I grew older, I would walk or take the bus from the Sunvale Manor projects in New Britain to Main St. every weekend (and sometimes during the week as well) where I had four movie palaces to choose from for

my cinematic fix. I would attend the matinees and stay for the evening shows as well. I'd take in a half dozen films a week and sometimes more and often multiple showings of each. I was insatiable. When I reached the legal age to drive, my consumption of films grew even stronger. At least once a week I would go to the cinema with my mom at the mall. She contacted me and asked if I would be interested in providing a film review column for the newspaper. The rest, as they say, is history. About a year ago, I started my website, "The Old Codger Critic" to expand my reach to cinemaniacs outside of the Facebook followers.

Plainville has become like a second home to me as I do the majority of film watching at the AMC Cineplex located there. So, I guess in a way we are actually neighbors.





Flea Prevention

Use a flea comb on your pet and wash his bedding once a week. Keep the outside of your house free of organic debris, such as rake clippings and leaves, and remember that fleas like to hide in dark, moist, shady areas. There are many preventative flea control products available, both as prescription and over-the-counter formulas.

Ticks

Ticks are parasites that feed on the blood of unlucky host animals, such as cats and dogs. Like mites and spiders, ticks are arachnids. Although their presence may not even be noticed by the host, ticks can transmit many diseases through their bite.

Tick Transmission

Most species of ticks require blood meals from a host to survive. Ticks bury their head into a host's skin when they bite and then gorge themselves on blood.

Ticks tend to be most active in late spring and summer and live in tall brush or grass, where they can attach to dogs and outdoor cats. Ticks can be transferred from pets coming into the household from outdoors. Ticks prefer to attach close to the head, neck, ears and feet, but can be found anywhere on your pet's body. Ticks are particularly prominent in warm climates and certain wooded areas of the Northeast.

How Do I know if My Pet Has Ticks?

Most ticks are visible to the naked eye. Ticks are often the size of a pinhead before they bite, and not noticed until they swell with blood. While these parasites rarely cause obvious discomfort, it is a good idea to check your pet regularly if you live in an area where ticks are prevalent, especially if he spends a lot of time outside. Run your hands carefully over your pet every time he comes inside, and especially check inside and around the ears, head and feet.

Complications Associated with Ticks

Blood loss, Anemia, Tick paralysis, Skin irritation or infection, Lyme Disease Lyme disease is a bacterial infection than can affect humans, dogs, cats and other mammals. Its primary carrier is the deer tick, which can attach to a dog or human and transmit the bacteria that cause the disease. Clinical signs of Lyme disease include depression, swelling of the lymph nodes, loss of appetite, fever, swollen, painful joints and kidney failure. Lyme disease is most effectively treated with antibiotics.

With prompt, proper treatment, your pet's condition should start to improve within 48 hours.

Tick Prevention

Many of the same products on the market that treat fleas also kill ticks and prevent against future infestation. Speak to your vet about the best product for your pet. Ensure a tick-free lawn by mowing it regularly, removing tall weeds and making it inhospitable to rodents by keeping garbage covered and inaccessible.







"Who uses words like...

In 1924 Plainville outgrew the Broad St. Elementary School built in the 1800s and so they built a second school on Linden Street. It had 8 classrooms, a Principal's office and a dramatic Roman Arched front door.

In 1929 an addition along E. Maple Street brought more classrooms and a high school space on the second floor. Before that, Plainville students went to New Britain, if they continued on to high school. During the 1970s another wing was added to the south of the property and attached to the original structure by a glass walkway along Linden St., creating a three-sided green space, the courtyard.

During this time, a pilot Special Education program was launched for Plainville's children adapted to serve a myriad of special needs. Appropriate accommodations for individual challenges were planned to provide a safe, comfortable space to learn, play and forge peer relationships. The professional staff included a full time nurse. The town-wide program found a home at the Linden St. School.

Helen P. Coughlin was a beloved local friend and advocate for these children. They planted a tree in her honor in the courtyard. The courtyard space was popular with staff and students. A wild flower garden was planted. When the belfry at Broad St. School was razed the homeless bronze bell, stamped 1874, found a spot in the quadrangle at Linden. The Student Council gifted a Linden tree, rare and fragile, for shade. The Conservation Commission found one for them and helped to plant it successfully. It thrived. The Auer family built a gazebo on the spot where student Christopher loved to sit, in his memory. Linden families and school staff donated a birdbath remembering Beth Altieri, a little girl who loved to watch the birds. A private citizen carried water there for years; hot water in the winter. Over the years it became a little memory garden as other artifacts were added. In time, the Special Education program ended and all students were mainstreamed.

Parents began to worry about the old building and its environmental safety. There was talk of tearing it down and replacing it. The voters did not agree.

Finally it was decided to build another addition, this time on the west side of the building, closing in the green space on all sides—now a quadrangle. It wasn't until construction was completed that people

plan was to demolish the old building and pave the property with a 40 car parking lot. The voters refused funding for this plan twice. It was obvious that the people did not want the building torn down. Some of the gifted artifacts were moved to the teacher's outdoor lunch area in the new building. Years went by. It became a ghost building. A fence was erected around it for the safety of the students and the public.

What to do?

A compromise plan emerged in February of 2015 proposing saving something from the old school building and the artifacts in the quadrangle, honoring its footprint, and creating a pleasant reflective open space for the people. The design included a safe off-road drop off and pick up area sorely needed to alleviate street congestion. The voters approved this plan.

A committee volunteered to oversee the transition for the people. Plainville Historical Society President, Nancy Eberhardt served as the Chairman. The quadrangle was cleared of artifacts and they were stored in preparation for demolition of the building. The Roman arch around the door of the 1924 building and some signs were salvaged. Nan proposed adding an outdoor classroom to the plan and the town added a 10 car parking lot.

The DiMinno family graciously gifted a stunning armillary sundial in memory of their daughter Mary Rose Faith DiMinno. The area seemed to begin to breathe a theme of nature, tradition, respect and community. The original vision called for sponsored benches and appropriate natural landscaping.

The Helen P. Coughlin tree was successfully transplanted on the property, closer to the school. The Linden Tree amazingly survived the demolition in place, thanks to the Manafort team who continually watered its exposed roots during a long hot summer. An outdoor classroom was erected in its shadow. The gazebo has been replaced.

The only artifact salvaged from the site that has been returned as promised is the concrete hand engraved Linden St. School sign at the corner of Linden and E. Maple Street. Some bricks from the old building were used in the re-structure. Nothing else stored has been returned. The 1874 Broad Street School bell's surround has been refurbished gratis, by a Linden parent, and its foundation has been laid at the site. President Eberhardt plans to compose and produce a proper plaque for the Broad St. School bell. Its foundation is in place. The Beth Altieri birdbath's foundation is also in place. The town has promised to return both to the site this summer when school is not in session.

There is no budget to complete this project.
