Plainville is Our Town: African-Americans You Should Know



Plainville Historical Society had a great program on "Plainville is Our Town: African-Americans You Should Know." Our member and presenter Gail Williams really made Plainville's African-American legacy come alive as we learned about so many who helped build our community. Joining us were descendants of some of the people who were highlighted. Looking at the photo below from left to right, they are: Carol Beverley: Niece of local businessman, musician, and athlete Bill Beverley, Michael Ardrey: Descendant of Lilly and Prince Livingstone who are believed to be our first African-American residents. Prince was a former slave. They lived on Red Stone Hill. Pat Carillo Beverley and Robert Carillo: Descendants of Plainville native Horatio Homer who was Boston's first black police officer - and the second in the U.S. Gail Williams: Presenter and daughter of local photographer Lutt Johnson and pianist Val Johnson, both of whom were also leaders at Redeemer's Church. Gail is the granddaughter of Clifton and Ceatter Johnson who moved to Plainville in 1909 to provide a good education for their children. In addition, Gail founded the well-known musical group Nzinga's Daughters. Susan Browne Root: Granddaughter of community leaders Herbert and Sophia Browne. Sophia is believed to be the first African-American woman to chair a Board of Education which she did in Plainville during the 1960's. Dayna Snell: Daughter of Gail Williams and granddaughter/great-granddaughter of the Johnsons. With Gail, she is in the musical group

The Cartoonists make a difference in lives. Their art provides comfort and an often needed chuckle to the troubled. The images certainly leave a historical legacy of the times. It is with great sadness that the Hometown Connection bids farewell to our volunteer resident cartoonist, Wendell Copeland....

When I was a very little girl, many years ago and the war in Europe was raging, a highlight of my week was reading the "funnies" on Sunday morning with my Dad. First always was Dick Tracy, the handsome policeman with the bright yellow fedora. He was always on the front page. Representing safety, authority and law and order in a scary, chaotic world, Detective Tracy commanded respect and always prevailed against evil. Colorful and confident, I loved him.

Cartoonist, Chester Gould developed this strip, presenting it to the Tribune News in 1931, just as the economy crumbled. Detective Tracy, his temperamental girlfriend Tess Trueheart, his best friend B. O. Plenty and his family, and his associates at the station, brought a stability sorely needed to our week. What bad could happen with Detective Tracy on the job? B.O. had a daughter named Sparkle Plenty who provided smiles and a gentle wave to family life. One Christmas her likeness became the most wished for toy. Dick Tracy used unheard of futuristic equipment. He had a 2-way wrist radio, a ring that could put a stamp on anything, and a host of fancy stuff considered mundane today.

I would sit through Gasoline Alley with my father and then, of course, Dagwood Bumstead, husband to the lady who was supposed to be the main character and Dad, held an office job. He chowed down on giant sandwiches for years while Americans stood in soup lines. "Blondie" was drawn by Steve Young and I thought that my Dad drew it.

## **Robert E. Lee, Town Manager's Report to Town Council** February 7th & February 22nd, 2022

Town Council Meeting February 7, 2022

#### **Crooked Street Bridge Repairs** – **State DOT Project**

- The State Department of Transportation has notified the Town of their plans to rehabilitate the Crooked Street Bridge over Route 84. Work includes the replacement of deck joints, repairs to steel members, field painting of steel elements, and repairs to spalled and cracked areas in the substructure.
- The work is not anticipated to have a significant impact to traffic, as Crooked Street would remain open to traffic for the duration of the project. The work will involve temporary shoulder and lane closures as needed. It is anticipated that this work will begin in the Spring of 2023.

#### ARPA Planning Committee Recommendation

- The American Rescue Plan passed by Congress has allocated \$5,189,198 to Plainville in response to the impacts of the COVID-19 pandemic. The Treasury Department has issued rules on how these monies can be spent.
- There are five general categories where these monies can be utilized: 1) Responding to the public health emergency and the negative economic impacts of COVID-19, 2) Replacement of loss revenue, 3) Provide premium pay, 4) Water and sewer infrastructure, and 5) Broadband infrastructure.
- After considerable review of each of these categories, the ARPA Committee is recommending that the Town Council choose to utilize the Replace of Loss Revenue option. This category was chosen because it is simpler and does not require extensive reporting requirements. It also provides for additional latitude in how the monies can be spent.
- The Treasury Department is allowing municipalities to receive our total allocation based upon a "standard allowance".

The ARPA Committee has also developed a preliminary list of where the monies would be spent if the "Replace of Loss Revenue" option is chosen. This list primarily includes larger capital improvements that have been in the 5-year plan. They include projects for the Fire Department, School Facilities, Public Works, Police Department, and other miscellaneous items.

Municipalities are required to seek public input on the proposed use of the American Rescue Plan monies. There is an item under New Business to conduct a Public Hearing on the use of the American Rescue Plan monies for Tuesday, February 22, 2022, at 7:00pm in the Municipal Center. A copy of the proposed list recommended by the ARPA Committee will also be put on the Town website at www. plainvillect.com

#### White Oak Redevelopment Project Update

٠

- Town staff continues to make progress on this project. In conjunction with the Connecticut Brownfield Land Bank (CTBLB), the Town drafted and published a request for proposal (RFP) on December8, 2021, to qualified and CT Department of Administrative Services (CTDAS) "preapproved" firms. These firms were cross referenced with list of finalists from the initial White Oak RFP for a full environmental site assessment in 2017.
- The purpose of the RFP was the following: updating the Phase 1 Environmental Site Assessment report as required by Connecticut Statute, finalization of a remedial action plan (RAP) in coordination with the development plan submitted by Manafort-Newport, noting both abatement oversight costs and a timeline to bring the site to a level deemed acceptable by the State for the intended reuse, and a cost estimate for preparation and submission of the Environmental Conditions Assessment Form.
- Following review of submissions,
   Town Staff has decided to move forward with interviewing BL
   Companies and Tighe & Bond as the two firms who articulated and

for the previously awarded \$1.17 million in Brownfield Remediation grant funding. The now "direct agreement" will simplify the process, having grant dollars & invoices be managed by the Town, much like the previous Brownfield Assessment grant funding, while allowing CTBLB to remain in their previously approved advisory and guidance role, assisting the Town during the remediation phase of the project.

- Most recently, Town Staff applied to the DECD CT Community Challenge Grant ahead of the January 14, 2022, deadline. Working with representatives from Manafort-Newport, the application was for an additional \$1.2 million in State funding, combined with the required 50% matching funds to be supplied by Manafort-Newport, bringing the potential total of additional funding to  $\sim$  \$1.8 million. These funds have been identified as a potential way to off-set construction costs related to the realignment and installation of the entrance/exit boulevard, traffic light as deemed necessary by CTDOT, paving, utility installation, site work, a covered CTFastrak bus stop vestibule on West Main Street, and access to open space on the northside of the property. A decision on the grant application is expected from DECD by April 2022.
- Finally, the proposed Agreement between the Town and Manafort-Newport, based on the previously agreed Term Sheet, has been drafted and sent to the developer. Their response to the proposed language in the Agreement is expected later this week.

#### Honor Heights Sewer Update

- Several developments have recently occurred regarding the possible installation of sewer lines into the Honor Heights neighborhood. The sewers would serve 84 homes that were constructed with septic systems, most of which are 40-50 years old. First, natural gas lines are
- First, natural gas lines are being extended to service the development of the Willow Brooks Estate project located just north of Honor Heights, Town staff has contacted Eversource Gas to see

\$560K. Plainville currently has over \$600K in State LoCIP Grant monies that could be utilized to cover the remaining balance.

• Finally, if the Town Council desires to consider this expansion, a Public Hearing on the proposed expansion could be held as early as April. If approved, construction would not be expected to occur until next summer.

#### Whiting Street Repaving Project

- Last May, Plainville received preliminary approval from CRCOG to receive a \$2,8M LOTCIP grant for the reconstruction of Whiting Street from Broad Street to Fairview Avenue contingent upon State of Connecticut Department of Transportation final approval.
- The State of Connecticut Department of Transportation has completed their review of the project's conceptual design and has directed the Town to modify the construction methods from total reconstruction to major rehabilitation, milling and repaving. The DOT directive has a reduced the cost per linear foot of roadway repaired, thus, as a byproduct of this modification, CRCOG has agreed to permit the limits of construction to be extended southerly beyond Fairview Avenue.
- The impact of this decision is that the Town will not have to use Road Bond monies for a good portion of the re-paving of Whiting Street from Fairview to East Street (Route 10) as previously planned.
- The Engineering Department is currently revising the conceptual design to reflect the State DOT's directive and will be establishing new limits of construction. A revised Whiting Street design is expected to be completed and resubmitted to the DOT by the end of February.
- Originally, it was believed that construction would occur during the 2022 construction season. As result of the DOT directive, construction will most likely occur in the 2023 construction season.

#### **Road Bond Discussion**

Each municipality is granted a "standard allowance" of \$10M for "loss revenue" calculation. Because Plainville's allocation is less than \$10M, the Town can choose our entire grant under this category.

Revenues received under the "Replace Loss of Revenue" can be spent on "government services" which is broadly defined as "any service that is traditionally provided by a government to its residents". This can also include capital expenditures. established the most complete understanding of the Town's goals, while also providing the most direct, concise, and affordable cost estimates.

- Interviews will take place via Zoom with both Town and CTBLB Staff later this week with a goal to bring a recommendation to the Town Council at the February 22, 2022, meeting.
- With the Town's commitment to ownership during the remediation process, Town staff continues to work with CT DECD staff to adjust the financial assistance agreement

if they would consider installing natural gas lines to Honor Heights in the event that sewers are constructed. Eversource Gas representative indicated that they would study the possibility of extending the gas lines and get back to Plainville in approximately 60 days.

Second, Town staff's preliminary cost estimate to install sewers is \$1.2M to 1.4M. It is anticipated that beneficial assessments would generate approximately \$840K (\$10K per home) leaving a balance of between \$360K and Town staff is preparing for the upcoming paving season utilizing Year 2 of the Road Bond II program. Town staff is requesting authorization from the Town Council to utilize the equipment rental rates outlined in State of Connecticut contract for roadway milling of streets to be paved during the 2022 construction season.

• The total amount of the authorization shall not exceed \$150K. The funds used to purchase

- The total amount of the authorization shall not exceed \$150K. The funds used to purchase these services will be drawn from the Roadway Bond account.
- There is an item under New Business that would authorize Town staff to utilize State Contract Bid equipment rental rates for roadway milling of streets not to exceed \$150K.

Survey The Town of Plainville has launched an online broadband interest survey for residents and business owners. The purpose of the poll is to gauge public support for building a municipally-owned fiber-to-the-home (FTTX) broadband network that would offer connections to all town residents and businesses. Plainville property owners can access the survey and learn more at plainvillect.com/broadband or by going to the Resource Center on the town website and clicking the Broadband Interest Survey button. The survey will be live until June 1, 2022.

Plainville is currently working to deploy a municipal fiber network connecting town offices, wastewater treatment facilities, emergency services, and educational institutions in all four corners of the town with the town center. This state-of-the-art fiber infrastructure, including 12.5 miles of aerial cabling and three underground spans running beneath major highways. Installation of the municipal network opens the door for Plainville to efficiently build out a town-owned FTTX network.

### PLAINVILLE'S GRAND LIST **INCREASED BY 14.9% IN 2021**

Ann Marie Heering, Assessor for the Town of Plainville has filed the 2021 Grand List with the Town Clerk.

The New Taxable Grand List is \$1,642,221,970. This is an increase of \$212,965,587 over the 2020 Net Taxable Grand List of \$1,429,265,383.

The Net Real Estate Grand List increased \$173,160,109 as a result of improvements to real estate and the state mandated revaluation of all real property.

The Net Motor Vehicle Grand List increased \$40,078,790 as a result of an increase in the value of new and used motor vehicles.

The New Personal Property Grand List decreased by \$282,312.as a result of 16 fewer personal property accounts.

### Town Council Meeting February 22, 2022

#### **Tomlinson Avenue Bridge Construction**

- Dayton Construction Company has notified Town staff that they will begin work on the replacement of the Tomlinson Avenue Bridge this week. Their initial work will include clearing & grubbing, test pits, control & removal of invasive vegetation, and the installation of a field office.
- Dayton will implement an alternating one-way traffic pattern when needed during this period. The Plainville Police Department will handle traffic control as well.
- Dayton is not anticipating the closure of the road to vehicular traffic until early April. The plan calls for the existing corrugated metal pipes be replaced with concrete box culverts.
- Pedestrian traffic will be maintained during the duration of the project. Town staff is working with the school administration and DATTCO Bus Company to re-route the busses when the road closes in April.

#### Pedestrian Crossing at High School

- Town staff has confirmed that the State Department of Transportation will allow for the installation of a Rapid Rectangular Flashing Beacon at the crosswalk located on Route 10 and Robert Holcomb Way.
- After further review with the D.O.T., the crosswalk will be able to remain in the same location. The project will include some work with the sidewalk to address the ramps leading to the crosswalk so that they conform to State specifications.
- Town staff is preparing a formal plan to the D.O.T. and expect that the work will be completed before the start of school in September. Monies to complete this project will come from the Town Aid Road (TAR) account.

## White Oak Remediation LEP Request for Proposals

- As reported at the last Town Council meeting, two firms have been interviewed to oversee the environmental clean-up of the White Oak site. Cal Hauburger, Matt Daskal and Mark DeVoe interviewed the two firms.
- It is their unanimous recommendation that the Town Council award this work to Tighe & Bond. This recommendation is based on their strong understanding of the project scope and needs of the community. The Tighe & Bond proposal was the most complete one of the respondents – detailing fully anticipated costs, timelines, and a good understanding of past and future efforts.
- They will serve as the Licensed Environmental Professional (LEP) to oversee remedial contractor bidding, investigation, clean-up, and required documentation.
- There is an item under New Business that would authorize the Town Manager to enter negotiations with Tighe & Bond of Middleton to serve as the LEP firm overseeing remediation efforts of the former White Oak Corporation property and to utilize previously secured State DECD Brownfield Remediation grant to fund said service in the amount of \$143,883.90. If approved, Tighe & Bond will immediately begin the planning work with final clean-up

bid. They have performed their work in an exemplary manner for Plainville.

- Town staff is recommending that the Town Council continue to engage Jones Construction to provide similar work this spring at the same unit prices that were bid in 2018. Town staff is also recommending that the purchase of concrete block be awarded to Cromwell Concrete under a State Bid Contract in an amount not to exceed \$50K. Cromwell Concrete has provided this material in previous years.
- There are two items under New Business regarding these recommendations.

#### **Disposal of Pickup Truck**

- Town staff is seeking approval from the Town Council to dispose of a 2003 GMC pick-up truck previously used by both the Roadways and WPC Departments. The truck has extensive structural deterioration, along both frame rails, a disconnected cross member and deteriorated rear shock mounts. These conditions are not deemed repairable, and the vehicle has no trade-in value.
- There is an item under New Business requesting permission to dispose of the 2003 GMC pick-up truck at auction.

#### COVID-19 Update

- A recent Hartford Courant article reported that there are different "risk levels" between CT towns based on how many people have been vaccinated. The Chief Medical Officer at Yale New Haven Health stated that the "vaccination rate in the population where you live is one factor that can impact transmissibility and numbers of infections". Other factors include "how much ventilation, distancing and masking" one encounters.
- As of last Thursday (February 17th), 71% of the Plainville population had been fully vaccinated. This compares to 76% in Southington, 72% in Bristol, 87% in Farmington, and 60% in New Britain.
- With respect to children ages 5-11, 33% of children in Plainville have been fully vaccinated. Surrounding Town percentage vaccinated between 5-11 years of age: Southington (33%), Bristol (25%), Farmington (58%) and New Britain (18%).
- Governor Lamont has lifted the state mask mandate for students in school as of February 28th. It is up to the local school boards to determine whether to continue a mask mandate beyond that date. Absent positive action to require masks in school, the mandate will sunset. Masks will still be required for those students when they travel on the school bus. This is a federal mandate.
- To date, Plainville has had 3,425 confirmed and presumed positive COVID cases since the pandemic started. There have been 51 total deaths reported. Case positivity currently stands at 47.7 per 100K population. Last week Plainville had 45 cases reported – the previous week this number was 72.
- For the week beginning January 22, 2022, unvaccinated persons had a 3.1x greater risk of testing positive for COVID compared to fully vaccinated persons. For the week beginning January 30, 2022, unvaccinated persons had a 15.2x greater risk of dying from COVID compared

#### Municipal Broadband Interest Survey

The Town of Plainville has launched an online broadband interest survey for residents and business owners. The purpose of the poll is to gauge public support for building a municipally-owned fiber-tothe-home (FTTX) broadband network that would offer connections to all town residents and businesses. Plainville property owners can access the survey and learn more at plainvillect.com/broadband or by going to the Resource Center on the town website and clicking the Broadband Interest Survey button. The survey will be live until June 1, 2022.

Plainville is currently working to deploy a municipal fiber network connecting town offices, wastewater treatment facilities, emergency services, and educational institutions in all four corners of the town with the town center. This state-of-the-art fiber infrastructure, including 12.5 miles of aerial cabling and three underground spans running beneath major highways. Installation of the municipal network opens the door for Plainville to efficiently build out a town-owned FTTX network. Senior Center:

The Biden Administration announced a 90-day extension on the pause of student loan repayment, interest, and collections through May 1, 2022. The pause on student loan payments will help 41 million borrowers save \$5 billion per month. # "Ask Sheila"

Q-1) I missed my Medicare Initial Enrollment Period; the 7 month period around my 65th Birthday. So, can I sign up for Medicare anytime since I'm already over 65?

A-1) No. You must have an Actual Enrollment Period. If you missed your Initial Enrollment Period, you can sign up during Medicare's General Enrollment Period (Jan 1 - March 31) then your coverage will start July 1st.

Q-2) Supplement Plan, Advantage Plan, Medi-gap Plan? Are these all the same?

A-2) The Supplement and Medigap Plans are two names for the same "Type" of Plan. This type of plan has a monthly Premium (Cost) and for the most part, after the annual deductible for Part B costs are met, it covers the 20% medical co-pays that Medicare by itself doesn't cover. The Hospital Deductible is also covered by the Supplement/Medigap Plan.

The Advantage Plan has no, or a small monthly Premium. This type of plan requires a set co-pay for each Medical service. For example, \$90 for an Emergency Room visit, \$45 for a Specialist office visit. It is a 'pay for use' type of plan. Q-3) I received a letter from Medicare saying I have a "Late Enrollment Penalty". Is there anything I can do to get rid of this Penalty? A-3) It depends on the reason you received this Penalty. You can request a review of your Penalty, and provide proof of prior Medical and Drug coverage. Or if you become eligible for "Extra Help", the penalty would be removed. #### LIVING WILLS maker to convey what they believe the incapacitated person's wishes may be.

A living will, also called an "advance directive", conveys a patient's wishes regarding treatment when those wishes can no longer be personally communicated. A living will must be constructed and authorized before the given individual is incapacitated in any way.

The importance of creating a living will is most evident in two particular forms. First an individual's wishes regarding life-sustaining treatment. Second, it is valuable for a person to identify a surrogate for decisions in time of illness or incapacity. The premise behind a living will is exactly the same as the premise behind a standard "Last Will and Testment", that is to provide instructions for treatment during time of illness or incapacity. The only major difference is an advance directive provides a surrogate decision

#### From the Desk of: Cal Hauburger, **Economic Development & Special Projects Coordinator**

180 South Washington Street: As shared in last month's update, Newport Realty Group has applied to the Planning & Zoning Commission for another aged-restricted development in Town. Located on South Washington Street, this development will feature a total of 12 units over 3 buildings. At the January 25th meeting, the Planning & Zoning Commission approved these plans. Work will begin shortly for site preparation and filing of building permits. The approval signals the ongoing market demand for alternative housing options, and further cements Newport Realty Group's commitment and investment in Plainville.

White Oak Update: Progress continues with the White Oak project. Under guidance of the CT Brownfield Land Bank, the Town has solicited proposals from licensed engineering firms to oversee remediation efforts on the property and within existing buildings, coordinating cleanup with the proposed redevelopment plans submitted by Manafort-Newport Realty, LLC. Responses were received from four firms - Loureiro, BL Companies, Arcadis, Tighe & Bond and reviewed by Town and Brownfield Staff. Interviews will be held to further delve into firms' responses, with a goal of making a recommendation to the Town Council at their February 22nd meeting for who, in the Staffs' mind, would best serve the Town in this role moving forward.

Work also continues to finalize agreements between the Town and both the State & development team. Regarding previously awarded Brownfield Remediation grant funding, the Town is seeking a "Direct Financial Assistance Agreement" with CTDECD. This relationship would be much like what was established under Brownfield Assessment grant funding from 2017, with funds and invoices being processed by the Town.

This would also allow CT Brownfield Land Bank to remain in the previously approved advisory and guidance role, assisting the Town during the remediation phase of the project. Once finalized, additional documents will be filed with the State prior to funds being released.

After finalizing a Term Sheet, outlining general parameters of the development, Town Staff and Manafort-Newport Realty continue work on finalizing a land disposition agreement, which further delves into details and responsibilities of each party throughout the development and beyond. A final version has been drafted by the Town and is currently being reviewed by the developers. A response is expected in the coming weeks.

Finally, Town Staff completed their effort in working with Manafort-Newport Realty to submit a CT Challenge Community Grant application to CTDECD in the amount of \$1.2 million. These funds have been identified as a potential way to off-set construction costs related to the realignment and installation of the entrance/exit boulevard, traffic light as deemed necessary by CTDOT, paving, utility installation, site work, a covered CTFastrak bus stop vestibule on West Main Street, and access to open space on the north side of the property. The program proved attractive, with over 50 applications being received by CTDECD prior to the January 14th deadline. A funding decision from the State is expected this spring.

Update: Construction efforts continue at the Americold building on Northwest Drive. Some supply chain delays were experienced at the height of COVID, and as a result, progress is behind what was projected. Site work will continue into early spring with parking lots to be paved. Currently, the goal is to obtain a Certificate of Occupancy (CO) by May 1, closing out phase one of the project, and moving into phase two which encompasses fit out and automation of the interior storage and retrieval systems. This is estimated to take roughly a year to finalize prior to official opening.

## **Rep. Petit Kicks Off New Session**, **Highlights Priorities**



State Representative William A. Petit Jr. (R-22) joined his fellow Republican and Democrat colleagues on the floor of the house, officially kicking off the 2022 legislative session.

A few of Rep. Petit's legislative priorities for this year include restoring public safety, improving portions of the police accountability bill, and protections for officers getting mental health assessments so they can seek treatment without fear of discipline or losing their jobs.

Additionally, he hopes to pass a comprehensive mental health bill to increase access, licensing reciprocity, and the number of school-based health centers along with providing adequate funding and resources to the Office of Victim Advocate.

"While the legislature will have many issues to consider during this shortened session, one of the most important items on my agenda this year is addressing the mental health issues we face, especially those in children,"

Rep. Petit said. "I am very hopeful that we will be able to shepherd a large multifaceted bill thorough the Public Health, Children's and Human Services committees to improve and expand mental health services throughout the state.

Rep. Petit also mentioned a goal this session is to try and find ways the legislature can work together to provide tangible tax relief to residents.

In the second year of a two-year legislative cycle, the main goal of the legislature is to make any necessary adjustments to the budget adopted in the previous year. Any new laws or adjustments to previously passed laws must be budgetary related. All bills brought forth in the shorter session must come through the committee that has oversight into the issue being presented.



- 3. Engage with your local school board. More than 14,000 school boards and 100,000 school board members across the country determine the shape and content of curriculum in their school districts, holding the key to how these various issues are addressed in American classrooms.
  - Identify local school board meetings to attend throughout the year (these typically occur monthly during the school year).
  - Stay abreast of board activities by reading meeting minutes (usually posted online after the meeting).
  - Locate school district budget documents and draft questions about spending on CRT/DEI-related activities, training, and personnel.
  - Look up the local school board's mission statement and become familiar with assigned textbooks.

2) Take 3 deep breaths before you give in to an unhealthy craving. Make a better choice.


3) Eat mindfully and slowly to recognize when you are full.

### Former Miss Connecticut Helps To Get Her Mother Out of Ukraine

Like other Ukrainian-Americans, Olga Litvinenko, who represented Connecticut in the Miss USA pageant, has been watching the news of her native land with horror and dread.

Litvinenko, who came to the United States from Kyiv as a child, has been glued to her phone.

"It's been really stressful, we have family there, so we're worried. Our great aunt, she's not picking up the phone. Every minute that goes by, it gets more worrisome," said Litvinenko, who competed in the 2017 Miss USA Pageant as Miss Connecticut. She currently runs a fragranceusiness.

Litvinenko was planning to visit Ukraine this winter, joining her mother, Tamara, who was already in the eastern European country this month. The plan was to reconnect with family in Ukraine. Their late father, Yuri Litvinenko, died in April of 2021, and he is buried in the capital city of Kyiv.

Then the clouds of war began to form in the east. Her mother was able to leave Ukraine Feb. 14 and return to their home in Greenwich before a Russian attack commenced this week. Tamara Litvinenko also brought back two rescue dogs from Ukraine, which complicated the paperwork for her journey back to the U.S.

"Luckily we were able to get her on a flight," her daughter said.

Litvinenko, a graduate of Greenwich High School and Syracuse University, has been keeping the news on "every minute, every second," the former Miss Connecticut said.

Invading Russian forces closed in on Ukraine's capital Friday. The assault, anticipated for weeks by the West, amounts to Europe's largest ground conflict since World War II.

Litvinenko said she has been disturbed to hear from friends in Ukraine who are running out of food. But, Litvinenko said, she was impressed by the number of volunteers who "are on the ground and ready to fight" and the determination of the Ukrainian people.

The Ukrainians want a peaceful independence, having their own country. It's a devastating time, extremely stressful. And they're fighting on their own."Litvinenko said she was planning to assist in the relief effort herself in coming days. # Tomlinson Avenue bridge replacement begins today

The long discussed replacement of the existing Tomlinson Avenue bridge begins today, with construction work continuing through September.

Dayton Construction is expected to complete the replacement of the existing bridge. The project will involve removing the existing corrugated metal twin culverts and replacing them with pre-cast twin box culverts made from concrete. The project will also include channel modifications and pavement repairs.

During certain phases of the construction, the bridge crossing will be closed to traffic. Detour signs will be put into place to redirect motorists. A temporary bridge for pedestrians will be installed during the project duration.

Town Engineer John Bossi said that this project has been in the works for close to 15 years and hit several "regulatory snags" along the way. The replacement is being done because the existing twin metal cuberts have deteriorated "The bridge was built in the late 1960s," said Bossi. "The new bridge will have precast concrete square culverts, which will have a longer service life."

Town Manager Robert E. Lee said that the project will come to around \$2 million, with 80% of the costs being covered by a state grant.

The years of delays with the project, Lee said, were a result of several required reviews by state and federal agencies. Other designs looked at in the past included creating a protective "sleeve" over the existing tubes or adding a third tube to increase the bridge's flood capacity. However, there were environmental concerns with these plans.

"The bridge travels over the Quinnipiac River and it was determined by the design corps and DEEP (state Department of Energy and Environmental Protection) that the original design would not allow fish to travel further upstream. We had to pretty much throw that design out and start over. The review process dragged on and on, but it is now finally actually going forward."

## What's in a Name? An Anthropological Perspective

The Washington Redskins are no more, now they are the Commanders. The Cleveland Indians are now the Guardians. The Farmington High School Indians are now the Red Hawks. The old names have been deemed "offensive" and "hurtful." The debate over team names and mascots has been building for a number of years. Charges of racism have been leveled at the use of some team names and mascots. Emotions often run high during the debate over team names. What is rarely, if ever, discussed is what does it mean to name? What purpose does naming serve in human society? How does the process of naming connect us to the past and why?

Humans invariable love to name. Our parents name us, their children, we name our pets, inanimate objects like our cars, boats, homes. All human societies name. As noted in "The Anthropology of Names and Naming" (2009) "Parents internationally are determined to get their children's names 'right'". Often the names given connect the child to his or her genealogical history. In New England through the 19th and into the 20th century first sons were often given their father's name while second sons were given their maternal grandfather's name thus preserving both the paternal and maternal histories of the parents in the naming of the children. For Christian, especially Catholic families the names of Jesus' apostles are commonly used to connect the child to the faith of their family. Jewish and Muslim families use similar religious naming schemes using the Old Testament and Koran. These naming processes link the child to his or her genealogical and/or religious heritage.

Naming is, from an anthropological position, a type of "sympathetic magic" going back to the days when humans lived in hunter-gatherer societies. The purpose of the name is supernaturally or symbolically gain the positive attributes of what the name represents. The clan of the bear would be named such as to draw the power and strength of the bear to the members of the clan that uses that name. The "spirit" of the animal would enhance those who took that animal's name for themselves. Warrior societies often chose an animal to represent themselves. We see this today in the animal representations of nations in the American Eagle, Russian Bear, British Lion, and Chinese Dragon (a mythological animal) as well as sports team names. The purpose of naming is to gain the positive aspects from what the name represents, whether that is speed, strength, courage, etc. as well as link those today to their collective past.

The current debate on team names completely ignores any mention of why we name, to preserve the past through the honoring of those who came before us or the use of "sympathetic magic" to gain the positive attributes of what the name represents. Naming invariably focuses on the positive. A relative or ancestor who besmirches the family name is often left out of a family's naming schematic. No parent chooses the name of a relative they despise or hold in disdain for their child. Likewise no sports team is named after something that invokes weakness. How many teams are named after possums, "let's play like we're a possum, play dead," or sloths, "we run like sloths, slowly." Names are chosen to evoke strength, courage, bravery; like a Brave not a coward. So what is fueling the debate on team names?

Much of the criticism of team names and mascots has come from the far political left, Marxist often in orientation, that has fueled perpetual outrage on being offended by most aspects of American culture and society. The slow but steady tilt of academia and education to a revolutionary Marxist mindset that indoctrinates the failings of American history and society without putting such history in a wider comparative perspective best exemplified by Howard Zinn's "A People's History of the United States" (1980) has conditioned a populace to blindly accept the argument assuming naming as a negative racial epitaph without questioning as to why anyone would give themselves an offensive name. In the end this process of finding outrage and offense demanding long standings names be discarded for more politically correct names is divorcing Americans from their shared history by ignoring the actual anthropological purpose of naming to gain the positive attributes of what the name represents and its historical and often genealogical ties to the past.

The royal family arrives at Sandringham estate in Norfolk, England to celebrate the Christmas holiday. Arriving late is Princess Diana (Kristen Stewart) who is in a fragile emotional state due to her husband, Prince Charles' (Jack Farthing) infidelity. As she fights to sustain her mental health, it becomes clear to those in attendance that all is not well with her. The stern Major Alistar Gregory (Timothy Spall), in particular, seems to be keeping track of her every move while attempting to assure she follow the scheduled routine. Diana struggles with her anxiety and depression while

her desire to live up to the expectations others have become more difficult for her to fulfill.

Director Pablo Larrain (Jackie) has made an impressionistic film with surreal elements in order to dramatize a traumatic period in the life of Princess Diana. This is not a factual account as the film reveals at the very beginning with the words "A fable from a true tragedy". He has made a gorgeous film with stunning cinematography by Claire Mathon and an appropriate morose soundtrack from Jonny Greenwood. The screenplay by Steven Knight can be a bit strident at times but realistically captures the descent into madness of a troubled young woman. That the young woman is Princess Diana makes the film that much more compelling.

Diana sees the three day holiday weekend as a chore considering the circumstances. It is now no longer a well kept secret that Charles is having an affair. For weeks now she has had to avoid the scandal hungry press and keep up a loyal front for Charles. Battling the sting of betrayal as well as an eating disorder, Diana is struggling. She is, by no means in a celebratory mood.

To call "Spencer" a unique film is to sell it short. It is uniquely different in all the best ways. We experience all the events through Diana, are guided by her perspective. And it is the perspective of someone who is losing their grip on the bitter realities of their situation. Feeling like the outsider, Diana is finding it more difficult to internalize the emotional conflict she is experiencing. She is hurt by Charles' betrayal and fed up with the royal rules she is expected to adhere to. The weekend is all mapped out for her including what to wear at each meal, at each special event (church, Quail hunt, opening Christmas presents) and for any audience with the Queen (Stella Gonet). The cool reception she received from the royal family has her wondering what her future will be. Luckily, her sons William (Jack Nielen) and Harry (Freddie Spry) are there to distract her.

Diana is defiant as she can be. She mixes up the wardrobe that has been laid out for her and wears what she chooses instead of what was chosen for her. She consistently shows up late for meals and ventures outside without accompaniment. She



confides in her personal dresser Maggie (Sally Hawkins) whom she considers a friend but remains secretive with the royals. But the royals aren't to be undone as they keep close tabs on her with Major Gregory showing up at each of her missteps to offer to steer her right and Prince Charles chastising her unacceptable behavior.

Diana's attempts to shake up the royals doesn't have the desired effect and her behavior becomes increasingly erratic. Finding a novel about Anne Boleyn, the second wife of Henry the VIII who had her beheaded when he decided to move on to his third wife, she begins to see her ghost walking the halls late at night.

Trying to escape the stifling demands of the royal family is a difficult task, especially when it also means swallowing one's pride as the once doting Prince dallies with another woman. Diana finds herself teetering on the point of being suicidal.

This brings me to the key element in the film. That is the performance of Kristen Stewart as Princess Diana. She is absolutely spectacular. She perfectly embodies her from an authentic duplication not just of her accent but of the nuances and inflections of her speech pattern. She has mastered her mannerisms so that you no longer see Stewart but are watching Princess Diana. It is a measured, magical, magnificent display of acting. She is on screen every minute of this film and you can't turn your eyes away from her. She is captivating and colossally charismatic. With award season upon us, Oscar should come calling. Spall, Hawkins, Nielen, Spry and Farthing all provide solid support.

This is an extraordinary film with a superlative lead performance. It's one of the year's very best films.

On East Street, across from DBK Jewelers, where the Starling building is today, was the best meat market that you could imagine. The building at the back which faces toward the road was Perrotti's. It was a dream, designed by Mike Perrotti, butcher extraordinaire. The entire meat area was refrigerated and freezing cold. A rack of white coats were offered for your comfort before the giant doors opened to welcome you. Even in July you had to wear a coat to go in to choose supper or a week's worth of main courses. They had everything from store made fat sausages for Saturday supper to a side of beef and it was all first quality. The best fresh ground hamburger was \$.89 a pound in 1962.

TuSimple's trucks could reduce shipping costs by a whopping 40%. And, of course, TuSimple's mission is more important than ever given the ongoing labor shortages we are dealing with. There simply aren't enough truck drivers to handle all the freight that needs to be distributed right now. That's why goods are piling up at American ports.



#### **INCREMENTAL ISLAM 23**

Under Islam, non-Muslims, also (derogatorily) called Kafirs, become a distinct under-class, sometimes referred to as najis, meaning filth. In fact, non-Muslims, no matter your religion, gender, age, or the catalogue of good deeds you may have accrued, are destined for Hell (ROTT w4.3). Unbelievers, in fact, are to be hated by Muslims for Allah's sake (ROTT w59.2) and are never to be taken by Muslims as friends (Quran 5:51). This last command to Muslims is so strong that it is mentioned multiple times in the Quran: 1:5-7; 3:10; 3:28; 3:85; 3:118; 5:80; 7:44; 9:23; and 53:29!

Here are a few examples of stark differences in how non-Muslims may be treated by Muslims as compared to their treatment of fellow Muslims. Non-Muslims may be killed, whereas killing another Muslim is a crime: (Quran 4:93): "For those who intentionally kill another Muslim, Hell will be their punishment, where they will live forever. The wrath of Allah will be on them, He will curse them, and they will receive terrible torture." Similarly, non-Muslims may be cheated, raped, enslaved, may not own weapons, and on and on.

The Pact of Umar made an exception for protection of non-Muslims provided that those non-Muslims paid the jizya, a tax which kept their heads attached to their necks. Living under these conditions, however, was exceedingly stressful for the non-Muslims since, if even one of them broke a rule under that pact, the Muslims had a right to retaliate against all those unbelievers!

Of course, Quranic pronouncements on treatment of non-Muslims will vary according to whether those rules were stated in the Meccan (early) Quran or the Medinan (post-hijra) Quran. The Medinan sections, however, are far more unforgiving and, unfortunately, are the authoritative rulings.
