



Town Manager Robert E. Lee ~ Report to the Town Council July 17th, 2017 Town Council Meeting



Gold Star Memorial Fund Update

- The Gold Star Fund has a balance of \$1,775. Donations received was \$3,775 and disbursements from the fund was \$2,000 leaving the current balance.
- During the fund raising efforts, it was noted that any remaining balances in the funds would be used to make improvements to Veteran's Park.
- At this time, Town staff is looking for direction from the Town Council on the potential use of the remaining monies in the Gold Star Fund.

High School Track Update

- The High School track has been milled and paved. That work was completed last week and has been approved by the inspectors from KBA.
- The pavement now has to "cure" for three weeks before the new track surface can be applied. The start date for the track resurfacing is now scheduled for July 27th and is expected to take approximately three weeks to complete.

School Building Project Update

- The grant application has been submitted to the State Department Administrative Services. Town Manager Lee spoke to the head of the school facilities unit and he indicated that they will be submitting a Priority List to the Governor and the Education Committee in mid-December and the General Assembly is expected to make grant commitments next spring. He also indicated that the reimbursement rate for Plainville is not expected to change from what was previously anticipated for this project.
- The timeline for the project is to have the work at Wheeler School begin next summer. In order to stay on that schedule, schematics need to be developed and submitted to the State over the summer. Once the schematics have been approved, design development and the construction documents would be produced.

- According to the existing Agreement with KBA, the cost to produce the schematics for Wheeler is \$160,000. This would be a reimbursable item once the grant is authorized. If the schematics do not move forward at this time, the project will be delayed by a year.
- The High School paving project is expected to receive only minor state reimbursement. The paving of the High School is planned for next summer as well. The contract with KBA calls for the design and bid documents to cost \$35,000.
- Unless the Town Council directs otherwise, Town Manager Lee will authorize KBA to move forward with the schematic development for Wheeler and the design work for the High School paving.
- The costs incurred at this time would be covered through short term borrowing or internally financed through the general fund.

Acquisition of State Land on Pierce Street

- Town staff is recommending that the Town acquire two small parcels of land owned by the State located on Pierce Street. The land was apparently planned to be used to construct an exit from Route 72 many years ago.
- It is anticipated that the State would transfer title at no cost. The land would allow for additional width along a portion of Pierce Street that could be used as part of the Farmington Canal Heritage Trail through Plainvi

Household Hazardous Waste Agreement

- The Bristol Resource Recovery Facility Operating Committee will be conducting three
- Household Hazardous Waste Collection Days next year. Those days will be on September 23rd in Prospect, October 7th in Bristol and April 21st in Burlington. The BRRFOC is requesting if Plainville would like to give our residents the opportunity participate in these three events.
- Cost to participate in the collection days would be based upon the number of participants.
 While thefinal fee has not yet been negotiated, it is expected to be in the \$85 to \$100 range per participant.
- Although it is not expected that many residents will participate, Town staff is recommending that Plainville have these collection days available. Money have been allocated in the Town budget to cover the expected cost of participation.

Farmington Canal Heritage Trail Update – FCHT Steering Committee

- The Gap Closure Study continues to move forward. On May 22nd a Public Information Session was held where four proposals for the north/south route were presented along with two proposals for the east/west routes to New Britain. Almost 100 persons attended this meeting.
- The Steering Committee met last week on July 11th and is recommending that Alignment C as the preferred north/south route and Alignment E as the preferred east/west route.
- Alignment C, as currently planned, would have a length of 4.75 miles of which 95% would be "off-road". It is known as the "western alignment" as it is the only alignment that goes west of Robertson Airport. It would use the public right-of-way where possible and would connect downtown Plainville, as well as the Tomasso Nature Park and Norton Park.
- The exact route for Alignment C is preliminary and will not be final until the Town Council has approved it. The Steering Committee and the consultants are in the process of redefining the preferred alignment and are exploring potential alternatives in a few difficult or sensitive sections of the alignment. The area around Tomasso Nature Park is one of those areas.
- The Steering Committee is planning a workshop in September where they will seek input and assistance on some of these areas. There will be further opportunities to refine the alignment and provide residents to give further input.

Bohemia Street Study

 After comments were made at the last Town Council meeting, Town Manager Lee requested staff to perform a speed study on Bohemia Street. Anyone interested may contact Mr. Lee to discuss the results. The Police Department has also been asked to conduct additional speed enforcement in that area as well.

- Marge Burris, 2 Mountain View

- Dr spoke against the proposed Alignment C.
- Robert Lauria, 18 Perron Rd voiced her concerns and spoke against the proposed Alignment
- Anthony Lauria, 18 Perron Rd echoed the concerns with the proposed Alignment C.
- Steve Santacroce, 4 Perron Rd joined his neighbors and spoke against the proposed Alignment

John Kisluk,

- 65 ForestvilleAve supports the residents and is not in favor of the proposed Alignment C.
- David Kemmeur, 38 Johnson Ave supports the trail but not as proposed in Alignment C. Maria DiMauro, 20 Perron Rd opposes the Alignment C proposal.
- Art Marino, 22 Tuttle Rd Bristol as curator of the nature park does not want the proposed path to disturb the park as it is.
- **Jeff Pooler**, 24 Perron Rd expressed safety concerns with the Alignment C proposal and spoke against the plan.
- Carmine Lalama, 37 Bohemia St questioned the path that cyclists are currently using through Town.
- **Joanne Edman**, 166 West Main St spoke in opposition of the proposed Alignment C going through Tomasso Nature Park.
- Lou Frangos, 10 Fairbanks St is sympathetic to the residents in the Perron Rd area and commented on the high school and Wheeler School projects.
- **Tim George,** 33 Johnson Ave spoke against the proposed Alignment C plan.
- Marilyn Shorette, 18 Milford St supports the Perron Rd residents.
- Robert Mercer, 215 Unionville Ave spoke against proposed Alignment C and against any disturbance to Tomasso Nature Park.
- David Spencer, 127 Milford St Ext. questioned other options for the bike/walking trail through town.
- Joseph Gohar, 14 Perron Rd voiced his safety concerns and is against the proposed Alignment C.

MAINTENANCE OF PRIVATE EASEMENTS...

What happens when it is impossible to get onto a piece of property without crossing another property? When this arises there is a need for a private easement or right-of-way. But who is responsible for the maintenance of the pathway... the property owner that is boxed in or the property owner that has the easement in their property? Public Act No. 14-67, effective on October 1, 2014, has provided a straight forward outline for such maintenance issues.

The owner of any residential real property that benefits from an easement or right-of-way, the purpose of which is to provide access to such residential real property, shall be responsible for the cost of maintaining such easement or right-of-way in good repair and the cost of repairing or restoring any damaged portion of such easement or right-of-way. Such maintenance shall include, but not be limited to, the removal of snow from such easement or right-of-way. This is the language directly from the Public Act. The party that needs the easement has to pay for the maintenance. Seems to be pretty fair that the party who needs the easement maintains it.

When multiple parties need an easement or a right-of-way to get to their properties the Act says they split the cost based on the proportion of the benefit they receive. So, if one property only uses 20 feet of the easement and the other property uses 100 feet of say a 120 foot easement the maintenance cost is based on those figures. It would be unfair to split the maintenance 50/50 in that scenario. However, parties are free to contract a different split of the costs and that agreement will be controlling over the Act.

Easements and Rights-Of-Way are going to become more and more commonplace as people multiple and spaces get tighter. Especially in regions like New England where space is already at a premium. So when buying or selling be sure that you are aware of possible land rights.

Petit, Martin Blast Malloy for Plainville Education Funding Hit

HARTFORD —State Representative William A. Petit, Jr. (R-22) and State Senator Henri Martin (R-31) blasted Governor Malloy for his announcement last Friday that he would slash education funding to 139 municipalities across the state including Plymouth. Under the governor's new plan, Plainville would lose almost all of its Education Cost Sharing (ECS) funding for FY 18 – a whopping \$8.2 million hit.

Rep. Petit today stated, "I believe the governor, with his executive order that cuts educational cost sharing money to many, many towns, is revealing his priorities, or it may also be a purely political move. I believe his priorities are to have municipalities pay for some, if not all of local teachers pensions, reduce general municipal aid, increase aid to cities and educational funding to Alliance towns and by his own admission on multiple occasions, avoid tax increases at the state level. By political, I mean it may be a move to have constituents and educational leaders pressure legislators toward a budget and provide political cover for those calling for tax increases to avoid decreases in educational and municipal aid, though this is contrary to his previously stated position. The House Republicans

have had an OFA vetted (the non-partisan Office of Fiscal Analysis) no tax increase budget ready since the end of April with several adjustments for revenue changes in the interim. This budget provided flat funding for both ECS and municipal aid. The Speaker of the House has been unwilling to allow this budget to be called to the floor for a discussion and or vote. During our last session, our leader, Rep. Themis Klarides, implored the Speaker to allow discussion and a debate and vote, and it was denied. It is time to put the people of Connecticut, and in this instance, our children, first, and proceed with a discussion on a no tax increase budget. We can produce a budget that will do so. There will be painful cuts, but that is what we all do at home when we face a fiscal crisis."

Sen. Martin said, "Sen. Martin said, "Some people have suggested that the Governor announced these cuts to force legislators to approve a budget. Republican legislators have been ready to debate and approve a budget since before the last day of the regular session on June 7. We presented budgets without tax increases that would create a new education formula that ensures all children in Connecticut receive a good education. But the Democrats who control the legislature by a slim majority refuse to even consider our proposals. It's time to stop the games and put the best interests of Connecticut's students, taxpayers, and most vulnerable residents before partisan politics."

The legislators noted that had any of the budget proposals put forward by legislative Republicans since April been adopted, ECS funding to municipalities would have been preserved without raising taxes, and this cut to Plainville's education funding would have been unnecessary.



Back to School Smartphone Apps & Programs

Full and part-time students, faculty, and staff of qualified accredited higher education institutions are eligible.

Notetaking Apps.... Microsoft OneNote:

Free for Windows, Windows Phone, Mac, iPad, iPhone, Android, Amazon, Web. OneNote is one amazingly feature packed piece of software. It has been a part of Microsoft Office for several versions. It was a hidden gem that few knew about. However, with tablets and smartphone popularity skyrocketing, OneNote has become a versatile tool that anyone can find value in.

In its basic form OneNote is note taking software and a planner. You can type notes, hand write notes (on tablets or smartphones), copy and paste text, take photo, video, and audio notes. All of the information you add to it is searchable. Even text in photos and documents.

He drove off in a huff cussing under his breath.


I went back to the phone and told the woman, "Sorry, but I don't think he's ready yet." Just wait until I tell him he blew two grand!

From Small Acorns to Mighty Oaks

The General Assembly of the State of Connecticut has yet, as of the writing of this column in mid-August, to pass a budget as required by the state constitution. threat of new tax increases looms as a means to close the projected budget gap. With cuts in aid from the state to towns many residents prepare for a hike in local property taxes. A proposed hike in the sales tax to $6.\overline{99\%}$ from 6.35% and an additional 1% sales tax on restaurant and hotel bills has been floated by the House Democrats. With the SEBAC agreement to temporarily halt wage increases for state workers and increased employee contributions to benefit packages there has been a call for more of the burden for new revenues to fall on business and "the rich." The main argument against increased taxes, especially those on business, has mostly rested upon the prior tax hikes by the Malloy Administration impact upon large corporations, like GE and Aetna, and their decisions to move their headquarters or parts thereof to the adjacent states of Massachusetts and New York. Ignored in this discussion is the impact on small businesses and the loss of those businesses to the long-term economic health of the State of Connecticut. For like the mighty oak which sprouts and grows from a small acorn so to does the large corporate employer come from the small startup. One only needs to look at ESPN in Bristol, and its parent

company Disney for such examples. ESPN began as the ESP network in 1978. Bill Rasmussen and his son, Scott founded the company with Ed Eagan. They incorporated the company in July of '78 for a fee of \$91. The cable network would begin to broadcast in 1979 after the purchase of a parcel of land that was a former dump in Bristol, Connecticut for \$18,000. The fledgling ESPN was able to secure investment from Gulf Oil in early 1979 after agreeing to use RCA's Satcom satellite to become a national cable broadcast company. Eventually Getty Oil's investment in ESPN was bought by ABC in 1984 and ABC itself was bought by Disney in 1995 bringing ESPN under their

corporate umbrella.

From a incorporation filing fee and modest property investment ESPN has grown in nearly forty years to the largest employer in Bristol and a major Connecticut company.

ESPN's corporate owner, Disney began in a part of a realty company's office in Los Angeles in 1923. Walt and his brother Roy began by producing a series of shorts combining live-action with animation called "The Alice Comedies." The success of those early films allowed Disney to grow out of the Disney Bros. Studio office and build the original Walt Disney Studio in late 1926. Walt Disney's studio would be on the brink of collapse several times, including 1928 when Universal took control of Oswald the Rabbit, Walt Disney's first successful cartoon series. Walt Disney's creation of Mickey Mouse and innovative use of sound in "Steamboat Willie" the same year revived the studio. Disney would eventually move into full-length animated films with "Snow White" in 1937, live action and documentaries in the 1940's, television in 1950, and Disneyland in 1955. At each juncture Walt and Roy Disney took great financial risks in which failure could have easily ended their company.

In Disney's case, like that of ESPN, the company was founded on a vision, a bit of money, and a lot of sweat. While investors were found both businesses had to prove they were viable, ESPN by locating and purchasing a site for their satellite dishes to go with their purchase of space on the Satcom satellite, in Disney's a number of successful projects leading to further investment ino the next. With the current tax and regulatory environment in Connecticut could either a fledgling ESPN or Disney survive long enough to become the corporate giants they are today employing 1,000s to 100,000s respectively? Where will the employers of the second half of the 21st Century in Connecticut come from? How many potential successful companies have left the state because their Rasmussens and Disneys decided this is not a place they can grow their startup given the onerous tax and regulatory conditions currently existing and more onerous taxes to come in Connecticut? Businesses, like plants, need fertile conditions and a proper climate to grow. How many business acorns will be able to grow into mighty business oaks in Connecticut's current unfertile business climate that is driving away existing companies? Maybe these are a few of the questions Legislators and the Governor should ask themselves.

What's your Story?

Last night, over dinner with friends, three stories where told. Each had a common theme, but with very different outcomes.

In the first story, a sweet dog was found hungry, dirty and scared. The number on the dog tag was called and the owner was overjoyed. Within minutes, he squealed into Susan's driveway, tails were wagging with many hugs and kisses all around.

Sometime later, still feeling the glow from this experience, Susan and David, found another wandering dog and stopped to rescue this poor pup. Very soon afterwards, they realized they had not rescued but had actually stolen the dog from the sidewalk in front of her owner's house. They found out later that this dog tends to walk to the end of the driveway and hang out. So instead of calling the owner, they stealthily brought the dog back to where it belonged, tail between their legs.

It must be their fate to find stray dogs, because there was one more encounter. This lost dog was found, fed and cared for as the owner was called. Instead of getting the same reaction they received from the first incident, the owner sounded less than overjoyed. "Sigh... He always gets loose... okay....I can be there sometime later today". Should they even give the dog back?

Stories can be fun, humorous, discouraging and inspiring. we might not all be great storytellers who can entertain over dinner, we tend to have these continuous tapes in our heads - stories about our life, hopes, dreams and fears. Some stories are wonderful memories in our life. Some are negative and can creep into our consciousness all too often. They are powered by self-doubt and fear. These stories don't make great dinner conversation and can often get in our way of moving forward. The lines are blurred between what is real, what we allow to be real.

Think about a book you may have read where the characters get stuck in their own perception of reality. As a reader, we have the benefit of knowing all sides of the story. You know it will work it out, because the novel has to pull everything together to a satisfactory ending. Meanwhile, we get frustrated with the characters because they seem to be doing everything in their power to stay stuck.

How many times have you been stuck in your own stories? I remember a time when I ran a conversation over and over in my head about what I thought a person said to me. In my mind, it was hurtful and I gave it more credibility than it deserved. One day, during a workshop, I re-examined this story and realized that I actually was not 100% sure what this person said. I may have filled in the blanks all on my own and

let it impact me for a very long time.

Do you create scenarios about what did or might happen? Do you get so worked up that the story begins to take on a life of its own and starts to physically affect you? We make stuff up or elaborate and turn a benign conversation into a real mess. We create outcomes that are not grounded in reality. Yet the impact they have on our mind and body are very real. At some point, we have to stop and acknowledge that this made up stuff might be good for a novel, but it is creating havoc with our emotions. We become stressed and negatively impact our health.

In comes emotional eating. Emotional eating is not a triple helping of crisp greens. Most likely it manifests by devouring a full bag of chips, while standing in the kitchen, without realizing how much you are eating or even getting any enjoyment out if it. It's a distraction; it numbs the pain, the shame and the anxiety.

When we focus negatively on stories in the past, it can cause depression and when we focus on what might happen in the future, it creates anxiety. The challenge is to focus on right now. Meditation teaches us to focus on the present. This doesn't mean that we can completely eliminate our stories or worries from creeping into our thinking, but we can diminish the effects. The practice teaches us to pause, acknowledge the thought and then tell it to go away so you can get back to the present and to focus on what is true for right now.

Next time you find yourself so wrapped up in what could of, should of, will happen, take a deep breath, pause and ask yourself these questions. Is this really true? Is it helpful? What power am I giving away by indulging in this story? How is my body feeling right now?

"It takes a lot of time and energy," said Pugliese. "On behalf of all citizens we share our deep and sincere appreciation for your charitable spirit and great actions. Many adults can't claim what you accomplished and I can't imagine what lies ahead in your future."

"From the first year I began this journey, the town of Plainville has been so supportive," said Nico. "My lemonade stands would not have been so successful if it wasn't for this amazing town. The police department, fire department, members of the community and all of you help make kids' dreams come true." Nico said that were it not for the outpouring of community support he has received he would not have been able to help grant six wishes to children with life threatening illness. "These wishes mean so much to these kids and their families," Nico continued. "These wishes mean that for some precious moments in time they don't have to worry about painful treatments, expenses and doctor's appointments. These wishes mean that families can be together and happy. These wishes help them find some peace."

Nico's father, Kyle, his mother, Angela, and his 8-year-old sister, Gianna, accompanied him to the meeting.



TASTE BUZZ...... PUMPKIN PIE

PIE CRUST

1 cup flour

2 ounces butter

4 tablespoons sugar

2 egg yolks

Put the flour on a board. Make a well in the center and put in the other ingredients. With your finger tips work them into a smooth paste. Push the flour over the paste and work it with the heel of your hand. When the mixture forms a smooth ball, wrap it in waxed paper and chill in the refrigerator for a least a half-hour before rolling out. Kine a 9" pie tin with the pie crust and place foil on top. Fill with dry beans and bake in a 400 degree oven for 10 minutes. Remove the beans and foil.

| PIE

2 cups cooked pureed pumpkin

1 cup brown sugar

6 eggs lightly beaten

2 cups cream

1/2 teaspoon salt

1 teaspoon cinnamon

1/2 teaspoon ground cloves

1/2 teaspoon mace

4 tablespoons finely chopped candied ginger

Combine the pumpkin with the sugar, eggs, cream and seasonings and blend well. Pour trough a strainer into pie shell. Sprinkle with chopped candied ginger and bake in a 375 degree oven for 30-35 minutes, or until pumpkin is set. Serve slightly warm with cheese or whipped cream. Serves 8.



~ Mary (nee Maria Lesiow) Czapor ~



of Plainville passed away surrounded by her loving family and entered into the peace of God and Jesus in Heaven on Monday, July 3, 2017. She was born August 9, 1922 in Zbora (village), County of Kalusz, Stanislawow Poland (which was annexed by Russia during WW II to become part

of the Ukraine). She was the daughter of the late Aleksander and Anna (Tulaj) Lesiow. Mary had one brother, Mikolaj Lesiow and two sisters, Ola (Lesiow) Federisen and Marta (Lesiow) Behun, who continued to live in the Ukraine with their families until their recent passing. Mary grew up in Zbora and lived her younger years helping out on the family farm. Although Mary didn't continue her education beyond a young age she could speak Russian, Ukrainian and Polish well. In 1935 at the young age of 13 she was sent by her father to a village about 14 miles from her home for a year to study with an accomplished seamstress. She earned her way by working as a nanny for the accomplished seamstress and at the end of the year came home to become the village seamstress/ tailor. She used those skills for the rest of her life.

As World War II raged in Europe Mary's life continued untouched for a while and on February 17, 1941 she was married in Zbora to Michael (Mikolaj) Czapor, he was from the nearby village of Paulszowka, County of Czortkow, Ternopil, Poland. He was in the Polish Army and fought for his homeland with his fellow countrymen. Unfortunately there came a time when they were separated when both Mary and her husband were taken prisoner by the Germans and put to work in various separate locations in Germany and did not see each other for years. During the years of forced labor Mary remembered some of the places she worked; as a nanny on a farm for a German family where she learned to speak German, as a housekeeper and kitchen help in a German Hospital and near the end of the war as kitchen help in a restaurant when the American forces liberated Europe in 1945. She, as other prisoners of war, were moved to Displaced Persons Camps as family members searched for each other. By some miracle her husband Michael found her at one of the Displaced Persons Camps and they were able to be together again. In December of 1946 while living in the Displaced Persons Camp, Altenstadt by Schongau, they welcomed a daughter Stella (Stanislawa). As the years went by her husband volunteered to work on the Camp Police Force and through those efforts found a contact with the American Red Cross. After recalling that an uncle had immigrated to America and with help from the Red Cross Michael corresponded with his Uncle Peter Chapor in Plainville, Connecticut and was able to arrange a sponsorship. So on March 19, 1949 they sailed from Bremerhaven Germany to New York City to enter the United States through Ellis Island arriving on March 29, 1949.

After Mary, Michael and daughter Stella were processed at Ellis Island they were put on a train headed from New York City through New Haven, Connecticut to Plainville arriving at night and being greeted by family. They worked hard at building their American dream. After working a full shift at Marlin Rockwell, Michael worked with Mary nights and weekends building their house at 7 Young Street which would be their home for 60 years. They welcomed more children, Peter in 1950, Helen in 1953 and Lucy in 1957. Mary also learned English, so now she could speak 5 languages and she became a US Citizen, another dream realized.

After her children were of school age Mary went to work first in the kitchen at Peterson Restaurant in Plainville, then in a garment factory called Park Fashions in New Britain and finally she worked for many years at Wasley Products in Plainville. Unfortunately in 1965 Mary's husband Michael passed away leaving her to continue to fulfill their

dreams with the help of her now pre-teen and teenage children. She did a wonderful job, all of her children graduated from college which was one of their very important dreams.

In her retirement Mary spent many happy hours at her sewing machine making clothes for her family, fixing and altering clothes for family and friends and teaching sewing, embroidery, knitting and crocheting to anyone who was willing to learn. She also bought dolls at tag sales, cleaned them, fixed their hair, made them clothes and then donated them to her church, St. Mary's Ukrainian Orthodox Church in New Britain, to be shipped to orphanages in the Ukraine. Over the years she donated hundreds and hundreds of dolls. Not to mention the hundreds of hats, gloves and scarves that she sewed, knitted or crocheted for the Ukrainian orphans. She was also a member of the ST. Olga's Sisterhood for many years at her church. She also enjoyed working in her gardens always making sure that she had time everyday to give her vegetables and flowers attention and then

sharing her bounty. Family was the center of Mary's life and she was a devoted and beloved mother, grandmother and greatgrandmother. She loved to have the family over to her house for holidays, birthdays, anniversaries, and picnics. She would cook for days and there was always enough food for unexpected guests. Every now and then one of us would be surprised, when we got home from work, to find that our "kitchen-elf" had shown up, did our dishes and left some pierogi, golumbki, or a lemon meringue pie in our refrigerator. This world was a better place because she was in it and her family and friends will miss her generous heart, gracious presence and her Babci hugs which she gave freely with a very strong squeeze. 




